LMC Nominates Candidates

Libertarians of Macomb County have begun the process of nominating candidates for public office for the November 4 general election. As of the April 9 meeting, the following nominations have been made.

State Representative:

District 25	Jim Allison
District 31	Jim Miller
District 42	Daniel Flamand

County Commissioner:

District 5	Jim McWilliams
District 6	Mike Brylewski
District 23	Erin Stahl

At the May 14 meeting, we hope to fill many of the remaining positions. They are State Rep. districts 24,28, 30, 32, 33 and 36 and County Commissioner districts 1-4, 7-22, 24,25, and 26. One or two spots may be left vacant if there is a libertarian running on another slate.

At the Libertarian Party of Michigan State Convention on June 7 we will nominate candidates for the Congressional seats in districts 10 and 12 which are shared with Oakland County. There will be specific caucuses for those two seats and the candidates chosen could be from either county. Anyone seeking one of those two seats should be at the convention.

Anyone seeking the State Rep or County Commission seats should be at our May 14 meeting. We do have some people who plan to run and have not yet appeared, and there may be candidates who are not decided about what office to run for. All LMC members are encouraged to attend and/or run.

McWilliams Elected Chair

At the meeting of March 12, Libertarians of Macomb County elected their Executive Committee for the 2008-09 year. Jim McWilliams was elected chair by unanimous vote to succeed Dan Flamand who chose not to run for re-election due to job commitments. Jim is new to the committee although he has been attending meetings regularly.

Jim Allison was re-elected Vice Chair, also by a unanimous vote. He served as Chair the previous two years and has been on the committee since 2003.

Keith Edwards was re-elected Secretary for his second term, also unanimously. He has previously served 4 terms as Chair, 2 as Vice Chair and on the committee for most years since 1982.

Marnie Edwards was re-elected Treasurer for her 12th term also without opposition.

Four candidates were nominated for the three at-large Director positions. On the first ballot, Mike Brylewski and Nicole Michalak were elected and Dan Flamand and Erin Stahl tied for third. Dan won the runoff. He served on the committee the last two years as Vice Chair and Chair. This is Mike's first year on the committee. This will be Nicole's 4th term as Director.

Although Jim McWilliams is new to the committee, he is a real spark plug, has written a number of letters to editors and came up with the Politigo game that we have played as an educational tool before or after meetings. And most of the committee is very experienced including three former LMC chairs. And, as you can see on pages 4-6, we are off to a good start on our letters to the editor campaign. Page 2

That leaves Mary Ruwart, author, long-time LPM activist who really knows her stuff and is a fine communicator, but unknown outside the LP. And there is former Congressman Bob Barr, who was pretty libertarian when he was in office except for being a drug warrior (since recovered, he says) and is on the LP Nat Comm. But the public remember him?

The national LP is currently in that periodic civil war between the pragmatists and the purists. The pragmatists say to hell with philosophy, let's get a candidate with a name even if there is none who will run. The purists say there wouldn't be an LP if we didn't have a philosophy so let's keep it and educate people with the best representative of it. Ron Paul would be a name and is fairly consistent, but he's running for re-election to Congress in the real world.

Now I'm a purist, but one who believes if a candidate is 95% OK and has a name, go with him or her. We did that with Paul in'88 and it was OK. I could go for Barr if I were up to date on whether he hits 95%. I suspect he does. I like Mary a lot, always have, and think she'd be a fine candidate. There's only one other possibility I can think of and that is former Minnesota Governor Jesse Ventura. He was always fairly libertarian and sounded more so in the recent Larry King interview. He was hinting that he's available for a party that has ballot status mostly solved and took openly libertarian positions. Hmmmm.

What's wrong with sovereign investments?

Sen. Evan Bayh ("Time for Sovereign Wealth Rules," op-ed Feb.13) thinks foreign SWFs investing in U.S. corporations is dangerous and that Congress should write rules. Any rules Congress writes will do harm.

Consider why nationalized corporations are bad. If a government controls a corporation, it will abuse its unlimited powers to destroy competition, leading to a nationalized industry. For that reason, everyone should oppose government stakes in *domestic* corporations. When a *foreign* SWF invests in a U.S. Corporation, it lacks those unique powers of government. Still, Sen. Bayh wants us to worry. He mentioned no specific mischief a SWF might cause, but he muttered about "agendas different from our own" and "interests other than maximizing profits." The reason he can't be more specific is that a SWF has no more power than you would with the same number of shares.

Suppose a SWF could choose a majority of directors and those directors made management do something economically foolish. Competitors would cheer and take the corporation's revenue. Consequently, the SWF-controlled corporation would suffer and lose its power to do its hypothetical mischief. So a SWF has no special power outside its home nation, and there is no reason to fear SWFs.

LPM State Convention

The Libertarian Party of Michigan will hold its annual State Convention on June 7-8, 2008 at the Best Western Gateway Hotel, 9191 Wickham Road, in Romulus. The Convention registration starts at 8:00 A.M. and the Convention starts at 9:00.

At the Convention, the LPM will nominate our 2008 candidates for Congressional and statewide public offices as well as for State Representative districts which include two or more counties in their districts. There will be district caucuses for those districts. If you are interested in running for those offices be sure to be there, because you will need to get nominated and fill out some paperwork. If you do, be sure you know what district you are in (bring your voter registration card) and the address of a bank for your campaign organization.

It is hoped that several candidates for the Libertarian U.S. Presidential nomination will be at the banquet. Up to nine people have expressed interest in running, but not all will be there. Some may have backed off already.

Lessons From Politigo

There are a lot of ways in which political issues can be discussed, debated, refined or discovered to be meaningless. Listening to the current Obama-Hillary debates is not one of them except for the discovery of meaninglessness. As I reported a year ago, LMC has found a fun way to do it in the Politigo game we play before or after a meeting. We discovered something new in our Politigo game before the February meeting this year.

In the game someone (usually Jim McWilliams) makes a list of political questions and we answer them on 3x5 cards and he reads them back to us and we vote for the three best. This time he made a board game of us and we were off to the races! Contestants included seven members and two visitors. We tried four questions, but I don't recall the exact order.

One was on education funding. All seven members advocated private funding in 2 or 3 sentences. The two visitors picked the current system, though one thought colleges should be privately funded. Some of the members' answers merely asserted that it's not a proper function of government. A couple of answers stressed personal responsibility of parents.

"What measures should society take to care for people unfortunate enough to lose their job? One of the visitors replied, "Nothin'!" He's on the right track. The other suggested lower benefits or roadway cleaning as encouragement to seek work and said free trade and correcting the trade imbalance would "head off" unemployment. Not bad for a "rookie, but he's accepted some false premises. All the members were on the right track, suggesting charities, stressing the free market as the way to avoid recession and catching the trick of substituting "society" for government or taxpayers. The class clown started his response with "Hippies need to cut their hair and someone will hire them." We do have fun with this game. A more serious answer was "'Society' (government) should not be favoring some people on the basis of need at the expense of others. This is a function of charities which can choose its beneficiaries according to its values at it's own expense."

Noise disturbance was another subject. A city council member wants to ban installing excessive audio systems (kickers) in their vehicles. How would you respond in debate? Both visitors would support a ban, though one would restrict it to after 9 P.M. The members had a wider variety of responses. Of the seven members, four said that current noise ordinances should be sufficient but that outlawing such equipment is inflicting mass punishment or a violation of property rights, one said do nothing, one was too vague to classify and one approved the ordinance with future review. I'm not sure he really meant it as it read. One of the four also said in opposition, "we will deny a person the joy of kicking out the jams when they're in a remote location, such as driving to Hawaii." More fun!

The unexpected happened with the question, "Should 2 cohabitant males have the right to adopt a child; what about 2 cohabitant females? There were two opposed, emphatically saying NO. Only one was a visitor, the other a member. Three members said either the birth parents or the adoption agency should decide and that people can shop for an agency that reflects their views. Three members and one visitor were for no restrictions. One of the latter said, "What we really should stop is irresponsible idiots bringing more children in the world. It sounds like an emotional reaction to the many childabuse-by-parents stories we hear, but leaves some big questions. Two others in that group stressed the need to find children good homes regardless. One said, "It might not be an ideal environment. . ." That could mean a reservation about gays, but a libertarian tolerance.

The three who favored the birth parents or adoption agencies making the choice offered a market solution to the people who are anti-gay as well as pro-gay. Whether that means the member was of one group or the other is not clear. (The class clown added, "Wait, hippies shouldn't be able to adopt, but that's it.") One could surmise that at least two of the nine responses are antigay or as many as six, the birth parents or adoption agency ideas maybe being a defensive measure. Who knows what people really believe? Yet, at least seven of nine held firm to libertarian tolerance.

Other LP groups might want to try the Politigo game as an educational tool, debate stimulus or just plain fun. The two visitors said they had learned a lot and were impressed. That alone is a good reason to try. Macomb Liberty 28960 Jane St. Clair Shores, MI 48081-1032
