Libertarians Nominate Bob Barr

In one of the most exciting battle in its 36 year history, the Libertarian Party nominated former Georgia Congressman Bob Barr to be its presidential nominee.

It took six ballots to make the choice that began with eight candidates. It was a tight race from the start, led by former Republican Barr and Mary Ruwart, the long time Michigan activist, now of Texas. Businessman Wayne Alan Root, former Democratic Senator Mike Gravel, LP activist George Phillies, long time medical marijuana user and advocate Steve Kubby, businessman Mike Jingoian and Christine Smith were the others. The latter two were dropped after the first ballot and each subsequent vote cut another candidate.

As the following stats show, the race between Barr and Ruwart were close, ending in a tie in the third and fourth rounds. When Root was eliminated in the fifth round, he threw his support to Barr settling the matter. Root was subsequently picked by Barr for the Vice President spot (surprise!) and nominated.

Smith missed the debate, but did not help herself when she did speak. Kubby was popular because of his main

issue, but few seemed to want a user on the ticket. Only Gravel's close supporters trusted him and Phillies ran as a "centrist" which meant that neither "purists" nor "pragmatists" wanted him and most were for Barr or Ruwart.

And that's what the race was all about. Purists were for Ruwart and Mary has always been a very strict constructionist of libertarian principle. She doubted the conversion of Barr and Gravel and called followers of Barr "carpetbaggers." She believes Barr became a member of the LP just to get the nomination. Pragmatists believed that the party will go nowhere unless it runs "name" candidates even if they are not 100% libertarian. Barr supporters aggravated Ruwart fans with some of their behavior that bordered on arrogance. Barr attempted to stay above the fray and praised Mary in his acceptance speech. Mary did not endorse him.

There are bitter feelings as there usually are after a close battle involving principles. In interviews since the convention, Barr seems to be adhering to libertarian positions, but often invoking the term "conservative." That may not be a repudiation of libertarianism, just an attempt to attract votes from the many conservatives who cannot stand, with good reason, John McCain. The argument for nominating Barr was always that he would boost the LP presidential vote because he is attractive to conservatives as well as better known than any other libertarian. He is already getting good TV exposure such as C-SPAN and CNN as the media detects the possibility that Barr may get enough votes to be a spoiler for McCain. The Wall Street Journal published an article of his on judicial selection.

Whatever one's view, the fact is that the Libertarian presidential candidate IS Bob Barr. He will make a good showing for the party only with full support.

Board gives better representation

Creating a county executive may sound like the perfect answer to our problems, but if voters look closely, they will discover this proposal will only hurt Macomb County residents.

Some have claimed that a county executive will become more efficient. It is true that the Board of Commissioners can sometimes be sluggish in its decision-making processes, but efficiency in policy decisions should not be the No. 1 goal in government.

In our current system, 26 commissioners are allowed to carefully deliberate on the issues of the day and they must form a true consensus before setting policy that will affect the entire county.

Instead of placing power in the hands of one executive, the political power is spread among the commissioners who represent different areas of the county. Some may tire of the endless debates and sometimes unresponsiveness of the board, but it should be seen that the system's checks and balances are working as intended.

Another problem with a county executive is the cost of a supporting staff. Not only must the taxpayers support an executive who earns a salary between \$100,000 and \$200,000, but we must also finance the creation of new bureaucracy to support this office. With these new employees, the county's liabilities will balloon into millions of dollars when including additional health care and retirement costs.

Paying 26 part-time commissioners \$34,000 a year will seem like a bargain compared to the costs of the county executive plan.

The county executive plan will further polarize county politics. The party that controls the executive seat will likely have great influence over the board and this will facilitate the creation of legislation tailored by the executive.

By maintaining our current structure, this situation will be prevented since each of the 26 commissioners has

equal political power and must form coalitions, sometimes across party lines, to pass legislation. This creates a better representation of the entire county's interests and will ensure that the political power will be retained by the people, not the bureaucracy.

If this ballot proposal succeeds, the residents of Macomb County will lose a form of government that has treated them well for so many years. We will have transformed ourselves from a low-tax, consensus-building county into a high-tax bureaucratic machine dominated by party politics.

Even though Macomb County government is far from perfect, creating a county executive will not provide the path to perfection as some would like you to believe.

Taxpayers can't be forced to support zoo

On August 5, Macomb County taxpayers will once again be asked to shoulder a new tax burden.

It seems that our elected officials who approved this new taxing authority, feel that we have an abundance of expendable income and expect us to subsidize the private operations of the Detroit Zoo.

Supporters of this proposal claim that costs per household will be so small that it will not impact anyone's budget, but this type of proposal will only open the doors to a new wave of taxation based on mandatory charity. At one time, charitable giving was a personal choice that individuals made based on their ability to give and their personal connection to the cause. Once a majority forces us to give our income to a private cause, it is no longer charity. Rather, it becomes a government-mandated transfer of wealth.

The Detroit Zoo is a great asset to the metropolitan area, but should taxpayers really finance a private organization? Why not have Macomb County residents foot the bill to bring back the Belle Isle Aquarium, or maybe Macomb residents can start picking up the tab for all Detroit area organizations?

There are thousands of organizations that require funding to support their operations, but it is best left to individuals to determine which groups deserve their money the most.

I urge those who enjoy the zoo to donate as much as they can to help and become a frequent patron. But, please do not force everyone, especially in these economic times, to support a private organization that needs to adjust its business model, just like the rest of us have adjusted. Vote "no" on the Detroit Zoo millage.


