Candidates Speak Out

HERE ARE EXCERPTS from statements issued by our LPWC candidates for Ann Arbor City Council:

Charles Goodman (First Ward): "As a philosophy student, I know that the major parties are intellectually bankrupt. Elect me and I'll implement Libertarian ideas to benefit our community. … There is an alternative. Vote Libertarian in November."

Kurt Verhoff (Second Ward): "If elected to the City Council, it is my intention to begin the process of reducing the size of governement by privatizing city services, selling city assets and promoting individual liberties."

Gabriel Quinnan (Third Ward): "My agenda consists of introducing legislation that will eventually

legalize medical marijuana. I will also increase competition ... by dismantling irrational zoning restrictions and encouraging suburban expansion."

Stephen Saletta (Fourth Ward): "I am opposed to the city income tax. ... I am in favor of legalizing marijuana. The government has no business regulating substances people put in their bodies. I oppose the park millage."

Gary Kaluzny (Fifth Ward): "I am totally opposed to the Parks Acquisition millage. It's another tax the taxpayers of Ann Arbor don't need to pay. ... I support legislation to put 'medical marijuana' on the ballot."

LPWC candidates have been covered by the Ann Arbor News, Agenda, WEMU radio, and have appeared before the League of Women Voters.
