Hutchinson Runs for US House, 7th District Seat

Robert ("Hutch") Hutchinson is running for the Michigan 7th District seat in the US House of Representatives. He is a retired electrician who also served 24 years in the Air Force. Hutch has run for the Scio Township Board and Dexter School Board in the past. He has been married to his wife Dorothy for 61 years and has five children.

Hutch switched from the Republican to the Libertarian Party this year to oppose the war in Iraq. He does not oppose war when it is necessary but feels it is wrong to invade countries that have not attacked the US. "This whole Iraq thing is blown way out of proportion," he says. "I don't think it was our place to go in when they haven't attacked us. It's not our place to be policing other countries." He says the root of our current economic problems is excessive war. □

Peninsular Place is located at 1000 N. Huron River Dr., Ypsilanti, MI 48197 (See Mapquest or call for directions). To reach the NON-PERMIT parking for Peninsular Place, continue to follow Huron River Drive through the light at LeForge. When the road splits off

in two one-way directions there will be a gravel parking lot on your left. There is a non-operative building there, but the lot is owned by Peninsular Place. If this lot is full you may seek a pay lot or meter on EMU's campus which will appear on your right.
