#### **Corliss Elected Chair**

Mike Corliss of Westland was elected Chair of the Libertarian Party of Michigan at its Annual Convention on May 5 in Frankenmuth. He had no opposition and was elected by acclamation. He ran for U.S. Senator in 2000.

Clare-Gladwin LP Chair Ghazey Aleck edged out incumbent Diane Barnes for Vice Chair, 39-37. He will be Affiliates Coordinator.

Keith Edwards of St. Clair Shores was reelected to his third term as Secretary over Tim Campbell of Holland, 39-35.

Assistant Treasurer Trafton Jean of Owosso moved up to Treasurer with a 52-25 victory over Bill Gelineau of Grandville.

Rounding out the Libertarian Executive Committee are five At-Large Members. Four were elected on the first ballot, Nancy O'Brien of Allen Park, Leonard Schwartz of Oak Park, Greg Dirasian of West Bloomfield and Diane Barnes of Eastpointe. Ben Steele III of Corunna won on the third ballot. The other candidates were Bruce Hoepner of Royal Oak, James Hudler of Chelsea and Tim Miley of Kalamazoo.

Only three of the nine elected were incumbents, Barnes, Edwards and O'Brien.

The Judicial Committee election had only three candidates so all were elected by acclamation, incumbents Bill Hall of Rockford and Jon Coon of Carsonville, and James Hudler.

## **Ballot Access Petition Drive Under Way**

The ballot access petition drive of the Libertarian Party of Michigan had its kickoff meeting at the Annual Convention on May 5 in Frankenmuth. BARC Chair Nancy O'Brien advised those present how the petition should be filled out and answered questions.

On May 15, the Board of State Canvassers met and ruled that our petition is substantially in legally specified form. Nancy O'Brien and Leonard Schwartz attended the meeting and Schwartz argued the case for the LPM.

There is a big mailing of petitions going out the week of May 14 including instructions on how to fill them out. You should start getting signatures right away.

The Elections Bureau had raised some objections to our petition form and although the Board of Canvassers ruled in our favor, we are revising the form and will use the revision as soon as possible. However, you may circulate either the original or revised form. We have just 180 days to get the required number of valid signatures and are shooting for 50,000! DO NOT WAIT until the perfected form is available. Circulate whichever form you have!

This will be a big job and everyone's help is essential. Get your family and friends to sign to sign right away and then move on to co-workers and others. Be sure to have them sign with the address at which they are registered.

Remember that each petition sheet must be signed by voters who are registered in the *same county!* Do not mix counties on the same sheet.

#### Convention Features Fun and Work

Michigan Libertarians gathered at the Bavarian Motor Inn in Frankenmuth on Friday, May 4, for the start of the three day 2001 State Convention. By the time they left on Sunday, they had partied, reviewed the platform and by-laws, attended meetings, voted, listened to some excellent speakers, enjoyed great food, and partied again. Who could ask for more?

Hypnotist Jim Hoke started things off at the Friday night welcoming party which loosened up the delegates and guests.

On Saturday, things started with a fine address by Washtenaw's Charles Goodman speaking on Community Interaction. He stressed the importance of Libertarian candidates getting local people to trust them by engaging in local community projects, before they even run.

Platform and By-laws debate followed along with the annual election of the Executive and Judicial committees as described elsewhere in this issue. There were also breakout sessions with Diane Barnes speaking on Interaction for the Introvert and Ghazey Aleck on Winning Elections. Nancy O'Brien gave instructions on how to get ballot access petitions signed.

At lunch, Larry Reed, President of Mackinac Center for Public Policy spoke on Settled Truths, seven principles of politics.

One was "Free people are not equal and equal people are not free." Talent, industriousness and willingness to save are qualities that differ in individuals. The only way to make people equal is to deprive some people of these qualities.

Next was "What's yours you tend to take care of, what belongs to no one tends to fall into disrepair. The incentives are always greater if private property rights are respected.

Third was the point made by Bastiat and Henry Hazlitt. Sound economics always means considering

the long run effects of actions and their effects on all people, not just the short run and the effect on some people.

Fourth, encourage something and you get more of it. Discourage something and you get less of it.

Fifth, no one spends someone else's money as he would spend his own. (Private citizens do not buy \$600 toilet seats, but the Defense Department does.)

Sixth, Government has nothing it can give someone that it has not first taken from someone else.

Finally, a government that is big enough to give you everything you want is big enough to take everything you've got.

In 1900, government took 5-7% of the income in the U.S. In 2000, it took over 40%.

It was a simple speech, but profound (and funny.)

At the Banquet, Bill Bradford, Publisher and Editor of Liberty (over half the audience subscribes) reviewed some of the problems that Libertarians have in campaigning. He said that according to the FEC reports, the 1996 presidential campaign took in \$3 million, but spent only \$8,800 on advertising. In 2000, it took in \$5 million be spent only \$323,000 on running TV ads (according to Browne.The FEC reports were made in such a fashion as to make classification of expenses difficult to understand.)

Bill's point is that we know how to raise money, but don't always know how to spend it. There is not enough market research done and because of high turnover in membership and positions, there is little institutional memory. Bradford advocates that more market research be done to test on issues, media, etc.

At the Sunday Brunch, Cameron Knowles, a talk show host on WSGW (790 AM at 3-6 PM) spoke. He talked of the media's superiority complex and some things we need to do. Call talk radio (he limits callers to once per week.) Write letters to the editor. Stay involved in off-election years. On issues, he advocates ending income tax withholding in favor of quarterly filing to make (Continued on page 8)

## **Attracting Youth in 2002**

According to the Rasmussen survey last year, 16% of voters support libertarian positions on political issues. But few of these libertarians vote for Libertarian candidates.

My own experience and recent articles in Libertarian Party News and Liberty indicate that our biggest problem is the "wasted vote doctrine." Even at our election night victory party there were LPM members who admitted that they voted for the lesser of two evils rather than for Harry Browne and Michael Corliss. We need to find good ways of encouraging libertarians to vote for Libertarians.

Last year the LPM spent over \$40,000 on radio ads. Although the ads were brilliant, Harry Browne got only 0.4%, Michael Corliss got only 0.7% and only one of our 16 congressional candidates got more than 2% of the votes.

My analysis: The ads were the wrong medium (radio) directed at the wrong audience (persons who listen to talk radio.)

My proposal on how we can best use our limited funds: We should focus on persons who are most likely to agree with libertarian positions and who are least likely to think that voting for a small party is a waste. Specifically, we should focus on young persons.

- Young persons are naturally rebellious and antiauthoritarian.
- 2. They are more open-minded than are older persons.
- 3. They are not addicted to voting for Democrats or Republicans.
- 4. They are not so accustomed to Democratic and broken promises that they are no longer outraged.

Specifically, we should pass out fliers at colleges and community colleges and place ads in student newspapers.

The best time for student outreach is not a few weeks

before the election when students are busy with midterm exams and term papers. Rather, student outreach should be at the beginning of each semester when students have more free time.

We should start test-marketing our fliers and newspaper ads in September, 2001, to attract students to help with our petition drive. This will also help us create new campus affiliates and strengthen existing ones well in advance of the 2002 election.

#### Richard Whitelock, Patriot

Former Chair of the Libertarian Party of Michigan Dick Whitelock died of kidney and heart disease on March 26 at Sperry Hospital in Lansing. He was 70.

Whitelock was a member of the LPM for over 20 years, serving several terms on the Executive Committee and as State Chair for two terms, 1988-90. He was interim editor of this publication in 1990. He was a frequent candidate for public office, including Congress, Michigan Senate, Michigan House and County Commissioner.

He was founder and long time Chair of the Ionia County Libertarian Party and its spark plug.

Dick was a prolific writer of letters to the editor, probably having more of them published than any other member. He originated, designed and often presented his "Screwball Award" to the Michigan legislator who authored the dumbest bill for the year, a mounted, 12 inch softball with a large screw protruding.

"He was the Libertarian Party in this area," said Ionia Mayor Dan Balice. "I always admired the fact that he had his principles and tried to act on them."

Whitelock said, "I am dedicated to the abolishment of all laws and regulations that prohibit people from making peaceful and honest decisions for themselves without interference from the government." He set the standard for activism.

Dick is survived by his wife Gloria, daughter Sheila Ricketts, sons Steve and Kelly, nine grandchildren and three great-grandchildren.

#### 2001 State Convention Minutes

The 2001 Convention of the Libertarian Party of Michigan was called to order by Chair Stacy Van Oast at 10:02 a.m. at the Bavarian Inn Lodge in Frankenmuth, Michigan.

Registered delegates were 58, quorum 29.

Convention rules were approved by voice vote. A motion by Bill Gelineau and Jeff Steinport to end Bylaws debate 5 minutes prior to the time limit to vote on all remaining original submissions to the Bylaws Committee was defeated 20-26.

Motion by Dan Lafavers and Al Titran that following the convention the Chair shall appoint a committee to resolve necessary changes of grammar, punctuation, numbering and other unsubstantial issues of language to properly implement the accepted changes to the Bylaws and Platform was passed by voice vote.

Platform discussion: A proposal to change Article II, Section 3, Elections, to read: We support the addition of the alternative "None of the above is acceptable" to all ballots. We further propose that in the event that "none of the above is acceptable" receives a plurality of votes in any election, A NEW ELECTION SHALL BE HELD FOR WHICH NONE OF THE LOSING CANDIDATES SHALL BE ELIGIBLE. New wording is in capital letters. Passed in committee 5-0, passed convention by voice vote.

Article VI, Section 6, Taxes: We call for the elimination of the double taxation that results when no allowance is made for previously paid sales tax on MERCHANDISE RESALES OR trade-ins toward new purchases. Passed 5-0 and by voice vote.

Article VI, Section 7 Taxes: WE CALL FOR AN END TO THE PRACTICE OF ADDING SALES TAX TO PRODUCTS ALREADY SUBJECTED TO SPECIFIC STATE TAXES, SUCH AS GASOLINE AND CIGARETS, WHICH RESULTS IN CONSUMERS PAYING TAX ON A TAX. Passed by committee 5-0, Convention by voice vote.

Article IX, Section 4:, Education: We support the restoration of local control and oppose federal and

state regulations and funding with respect to local curricula. (including out-come-based education, Goals 2000 and school-to-work legislation.) Wording in parentheses is deleted. Passed committee 5-0 and Convention by voice vote.

Article VII, Section 4, Economy: Add the following sentence to appear before the final sentence. WE ALSO CALL ON THE LEGISLATURE TO END THE STATE MONOPOLY ON LOTTERIES. Passed in committee, 4-1 and at Convention by voice vote.

Bylaws discussion: Article VII, Section 1, Conventions: The Party shall hold an annual convention each year between April 1 and JULY 31, performing such business as required herein. Passed in committee 4-0 and at Convention by voice vote.

Article VII, Section 7, Conventions: A person who has never been a member of the Libertarian Party (of Michigan) must become a member at least 60 (30) days prior to State Convention before being allowed to vote at that Convention. Passed in committee, 4-0. Issue divided at Convention. 60 (30) failed by voice vote, deletion of (of Michigan failed 19-22.

Article IV, Libertarian Advisory Council repealed.
Passed 4-0 in committee, in Convention by voice vote.
Article VII, Section 2, Conventions: The Party shall hold a convention WITHIN 45 DAYS upon the call of the COMMITTEE (Council) OR WHEN PETITIONS ARE SUBMITTED BY 10% OF THE CURRENT MEMBERSHIP. Passed committee 4-0, in Convention by voice vote.

Article X, Fiscal Year: The fiscal year of the Party shall end May 31. Passed committee 4-0, in Convention by voice vote.

A proposal to mail to members a report on funds raised, spent and on hand annually failed in committee 2-3 and at Convention by voice vote.

A proposal to consider By-laws in odd-numbered years only failed committee 1-3 and in Convention by voice.

A proposal to create a membership growth committee failed in committee 1-3 and in Convention by voice vote.

#### 2001 Convention Minutes (Continued)

A proposal to extend the terms of office for the LEC members failed in committee 1-3 and in Convention by voice vote.

A proposal to keep local candidate caucuses open until Michigan's legal deadline failed in committee 1-3 and in Convention by voice vote.

A proposal that the LPM would collect an additional \$10 in dues and send it to the county groups failed in committee 1-3 and in Convention by voice vote.

Time expired before the two final proposals submitted to the committee could be voted upon.

#### **Executive Committee Minutes**

The meeting was called to order by new Chair Mike Corliss at 12:34 on May 6 at the Bavarian Motor Inn following adjournment of the Convention. Present were the Committee: Mike Corliss, Ghazey Aleck, Keith Edwards, Trafton Jean, Diane Barnes, Greg Dirasian, Nancy O'Brien, Leonard Schwartz and Ben Steele III. Also present were Tim O'Brien, Stacy Van Oast, Bob Van Oast, Marnie Edwards, Lynn Fitzpatrick, Dick Jozwiak, Rae Jozwiak, Jamie Lewis, Rosemary Racchi, Al Titran, Jeff Steinport, Steve Townsend, Dave Nagy (later) and possibly others.

Corliss began to announce appointments to committees starting with Newsletter. Greg Dirasian moved, Nancy O'Brien seconded, that we spend \$1,000 for new software and hardware to produce new graphics for the newsletter and that a committee be appointed to run the newsletter. A debate followed as to what the purpose of the newsletter was and whether the current format was good enough. Nancy O'Brien said the current format was not good enough for outreach. Keith Edwards said the purpose was primarily to provide information to our members and contributors and only secondarily for outreach. He suggested we do a special, more glitzy outreach publication. Information for members is not always

consistent with what we would use for outreach. Corliss then asked Dirasian who would be Editor and Dirasian replied that he, Dirasian, wanted to be editor. (No written copy of the motion was received by the Secretary.) A lengthy discussion followed. Motions to call the question and to table failed.

It was observed that there would be other increased costs in connection with this proposal, including cost of printing. Further details on the proposal would be needed before any decision. More discussion followed. A second motion to table, until the next meeting, passed 5-4.

Corliss then appointed Edwards Editor.

Other appointments were made: Ghazey Aleck to Affiliates Coordinator, Nancy O'Brien to BARC Director, Keith Edwards to Parliamentarian and Speakers Chair. Ghazey Aleck will be responsible for Affiliate News for the Newsletter. Other announcements of appointments will be made as the Chair is able to contact interested members.

Copies of the proposed Executive Director Contract were passed out. It was moved that discussion be tabled until the next LEC meeting so that Committee members would have time to review it. Passed by voice vote.

Those attending the LAC's February 20 meeting got to hear from Ray Wilson of the locally based "Citizens for School Accountability," a conservative anti-tax

group which has fought against higher school taxes ever since Proposal A promised to keep our property taxes low in exchange for a 6% state sales tax.

## **Ottawa Trashes Monopoly**

Hudsonville – Ottawa County Libertarians have helped defeat a proposal by members of Hudsonville's City Commission to change the way trash is picked up. Currently there is a free market system where consumers contract with any of the dozen local providers. The city is still looking for ways to meddle and is now considering licensing and regulating waste haulers. Except for one commissioner, nobody else has complained or asked for this interference. The Ottawa County Libertarian Party will continue to monitor the situation and stick up for the free market.

Jeff just received a major endorsement from a community group composed of former board members and citizens who are very active in the school district. Jeff is the only candidate supporting decentralizing control, cutting administration, outsourcing services and opposing tax increases. He is running a very active campaign with mass direct mail, door to door canvassing and speaking with community groups to build consensus.

Jeff Steinport's election to the Grand Rapids Board of Education would be a major victory due to the sheer size of the district with 180,000 constituents and 27,000 students served.

## Washtenaw Buries Rec Center

Washtenaw County Libertarians were a major factor in defeating a proposal to build a \$28 million Recreation Center in Ypsilanti Township. The measure went down by more than a 2-1 vote.

#### Barnes Leads Eastpointe Referendum

Libertarians of Macomb County Chair Diane Barnes is leading a petition drive to overturn Eastpointe's new "Living Wage" law. This law provides that companies that receive tax incentives or do business with the city must pay their employees at least \$8.23 per hour if they do not provide benefits or \$10 if they do not. About 60 cities in the U.S. have such laws including Detroit and Warren.

The law is the typical ploy of labor unions to jack up wages or to cut non-union companies out of the bidding. Of course, companies that do not meet the law do not get the contract and their lower skilled employees, who need it most, are not paid at all.

Sadly, the Michigan Chamber of Commerce representative is no help at all. He exhibited his ignorance by saying in opposition to the law, "If you agree the minimum wage is too low, then the solution is to lobby Congress to raise the minimum wage." But the COC supposedly fights against such raises. With "support" like that, who needs opposition!

Fortunately, Diane has no need of such incompetent "help." With a motivated band of very competent libertarians, she went after the 286 valid petitions to put the law on the ballot and they collected nearly 500! They were quickly approved and the City Council now needs to vote on repeal. If it fails, the issue goes on the ballot this fall. Diane reports that hardly anyone refused to sign. With a City Council that passes such a law while the city is under investigation for sweetheart contracts, payoffs, wasteful spending and a school board that is its equal in scandal, one wonders why they don't just change the city name back to East Detroit.

That doesn't bother the feisty Diane one bit. She just moves ahead with a plan to publicize the issue with the help of stalwarts like Kevin Grand, Jim Miller, Erin Stahl, Al Titran and Vicki and Rick Beeman.

The campaign has been closely covered by the Detroit News and Macomb Daily with major spreads and pictures on April 26 and May 11 respectively.

I used this decision on the Browne campaign as an example, but they probably made a hundred good decisions as well. And I'm sure they had projected more income than they eventually received. That is always one of the tough things to decide in a campaign.

## **Tips for Speakers**

On page 5 of this issue of Michigan Libertarian Leonard Schwartz writes of the need to attract youth to the Libertarian Party by passing out fliers at colleges and placing ads in college newspapers. This could lead to the formation of college Libertarian affiliates. That's a great idea.

I think we can do even more. I have been speaking at high schools and colleges since 1992 and have found that young people are becoming more receptive to libertarian ideas each year. I would like to expand this function.

At the State Convention this month, I asked affiliates to look for some members who are free to speak to schools during school hours, generally from 7:15 A.M. to 2:30 P.M. Not too many of us can meet that schedule. I've been lucky because my boss over these years has been very supportive. Leonard Schwartz of Oakland County immediately volunteered. Some professional people like Leonard have that sort of flexibility. I can do Macomb and Wayne County, but we need help in other counties.

I would like to hold an audition-training session for potential speakers. If you have a good understanding of libertarianism, can meet the schedule requirement and can handle tough questions from uninhibited young people, let me know and I'll set up a training session. There is more to being a good speaker than meets the eye (or ear.) Just spouting boring libertarian cliches is not enough. Most of the time spent in a classroom appearance is in the Q and A, deriving an answer to a question you've never heard before from basic libertarian principles in seconds while maintaining poise and assurance.

Here's an example. If you say that the LP is opposed to intervening in wars, some kid is going to ask, "But what about World War II? We were attacked by the Japanese and had to fight back!" And from his standpoint it's a good question based on faulty teaching at school and home.

If you know that in the 1920's Japan was moving

toward a free market and international trade as well as universal suffrage and liberty, but was economically devastated by the Smoot-Hawley tariff of 1930 which destroyed the silk trade, you can show how our bad tariff policy helped create the great depression that gave the military a chance take over and retard Japan's progress. You add that when President Franklin Roosevelt placed the oil embargo on Japan in July, 1941, and froze its assets, Japan was forced to attack as it looked elsewhere for oil. So, you have to know your history as well as principle.

None of that helps, however, if you come across as a superior know-it-all, talking down to them. You have to be unflappable. You have to be "on stage" as they walk into the room without appearing to do so, looking relaxed, friendly and confident without getting mushy about it. Making eye contact with those individuals who look at you as they sit down and looking at everyone at some time during the class rather than staring at the back wall are important techniques, especially while you're trying to remember your introductory remarks or trying to answer that tricky new question.

It's not as easy as it looks. The first time I went to one particular school, I was told by the teacher after the class that he liked my presentation and added, "The last time we had a Libertarian in here, he was a real flake!" No doubt that guy knew all the libertarian cliches ("the market will take care of that!") but had no idea of how to speak in terms his audience could understand. I've been back every year since.

Incidentally, these remarks apply not only to speakers in classrooms, but also to candidates on the stump.

So, if you're interested, let me know. If you're a bit shy in public, don't let that stop you. I'm a recovering introvert myself and I love talking with college and high school kids.
