Tipping Points and Libertarian Success

Social psychologists are amazed at how quickly people's preferences can change. This applies not only to clothing and music, but also to religion and politics.

Chaos scientists explain that a complex system can have several equilibriums. A system often stays at one equilibrium for a long time then suddenly shifts to a different equilibrium.

The sudden shift can be triggered by a small change in one independent variable. Chaos scientists call this the "butterfly" effect. Social psychologists call this the "tipping point" effect.

Why is this important to Libertarians? Some Libertarians get frustrated at our lack of success and drop out. Others, like me, have remained active in the party for over 20 or 30 years. We have not lost faith. We are working to reach the tipping point.

With effective marketing, we can make 2006 the tipping point year for the Libertarian Party of Michigan. My optimism is based on several factors.

1. When I campaigned for Supreme Court at street festivals last year, I chatted with persons who passed out campaign literature for the two big parties. The Democrats told me how much they hate the Republicans. The Republicans told me how much they hate the Democrats. Rarely did anyone have anything good to say about their own candidates. Even volunteers for the two big parties apparently don't like their own party; they merely hate the other big party.

2. When I campaigned for Supreme Court last year, many people asked which party nominated me. When I said "Libertarian," the positive responses greatly outnumbered the negative responses.

National Membership Dues and UMP Changes

On August 6, 2005 the Libertarian National Committee passed motions that will eliminate monetary membership dues for the national party and phase out the Uniform Membership Program (UMP).

As a result, the national office has focused its efforts into restructuring the Libertarian Party into an organization

focused on running candidates and winning elections rather than a membership group.

The elimination of national LP dues, which is actually a reduction of dues to \$0, becomes effective January 1, 2006 and will result in national membership being determined by those who have signed the non-initiation of force oath. The 2006 national convention delegation allotments will not be affected by this change as they are determined by membership numbers before 1/1/06.

A new system for delegate allocation will be developed and incorporated into the LP bylaws at the Portland convention. States will be responsible for choosing their own delegates and setting their own delegate membership requirements, just as they have been in the past.

Those states who are currently in the UMP program will be given the opportunity to phase out over the next 12 months by receiving monthly checks that will decrease by 1/2 each month; or UMP states may opt to take six more full monthly checks.

I supported the move away from a member-based organization and I share the vision of the LNC in moving the party to another level. In addition, I believe that this restructuring will prevent possible future problems with FEC regulations, especially the Bi-Partisan Campaign Reform Act (BCRA) which we are subject to by law.

Currently, a new affiliate agreement is being worked out between the state parties and the LNC which will allow reciprocal access to database information, among other privileges and responsibilities.

I am aware that some states may experience financial difficulties transitioning from UMP to non-UMP based

budgets. I believe we can work together to overcome this with better fundraising and training.

Preparations are already underway to set up the Libertarian Leadership College, which will provide professional training at the national level. State officers and activists will be offered courses in the areas of ballot access, FEC compliance, fundraising, database usage, member recruitment, and candidate recruitment and training.

In addition, Emily Salvette and I are working with the states in our region to assist them in making the transition. I recently met with my state's leaders and found that fundraising and leader motivation are the two biggest problems confronting us at this time. These are areas that we would like to see addressed in local and regional training sessions. I would also like to see addressed in local and regional training sessions. I would also like to hear from you about specific concerns in your state.

I have 15 years of experience serving in various various capacities in the Libertarian Party, and I want you to know that I am here to help you make this transition smoothly. 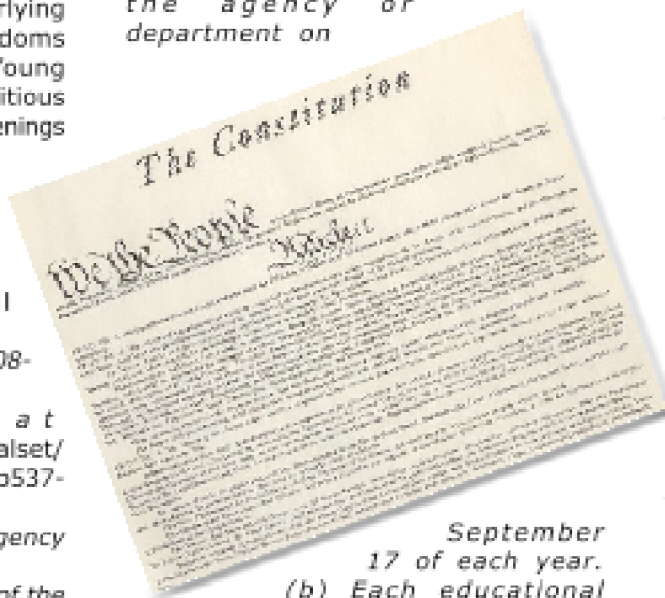

The new law - Public Law 108-477:

(a) The head of each Federal agency or department shall—

(1) provide each new employee of the agency or department with educational and training materials concerning the United States Constitution as part of the orientation materials provided to

the new employee; and
(2) provide educational and training materials concerning the United States Constitution to each employee of the agency or department on



September 17 of each year.
(b) Each educational institution that receives Federal funds for a fiscal year shall hold an educational program on the United States Constitution on September 17 of such

year for the students served by the educational institution.

The irony of this new law requiring the teaching of the Constitution is that it is probably an unconstitutional law! The Constitution does not delegate any specific powers of education to the federal government. This is another good point of discussion, along with how our nation has dealt with unconstitutional laws, such as the abuse of eminent domain, and the war powers act which sidesteps the Constitutional requirement of a declaration of war by Congress.

LEC July Meeting Minutes

These minutes have not yet been approved by the committee. It is possible that there will be additions or corrections at the next committee meeting. If so, they will be published here.

A regular meeting of the Libertarian Party of Michigan Executive Committee (LEC) was held 1:10 pm, Sunday, August 7, 2005 in the Conference Room at the Party's Headquarters, 913 W. Holmes Road, Lansing, Michigan, with the Chair presiding and the Secretary present.

Present were Chair Nathan Allen, Vice Chair Scott Boman, Secretary James Hudler, Treasurer Will Tyler White (arriving at 2:55 pm), Political Director Leonard Schwartz and Newsletter Director Andrew Wrenbeck. This was the first LEC meeting for newly-appointed Director Wrenbeck. Kai Phillips, present throughout, began participation as Communications Director during the course of the meeting, as detailed below.

Present at the meeting also were several Libertarian Party of Michigan (LPM) members who are not members of LEC: Jim Allison, Bill Bradley, Bob Broda, Bill Gelineau, Arthur Gulick, Gil Meyers, Nancy O'Brien, Tim O'Brien and David Raaflaub.

The Chair read a letter of resignation of LEC Membership Director Greg Dirasian, which resignation the Chair accepted.

Minutes of the previous Libertarian Party of Michigan meeting, held June 12, 2004 were approved.

Political Director Schwartz reported that racial preference brochures authorized at the previous LEC meeting have been printed and are ready for distribution. Schwartz reported that LPM members currently running for office are: Brian Kelly, running for mayor of Pontiac; Fred Collins, running for mayor of Berkley; Andy LeCureaux, running for reelection to the Hazel Park City Commission; Lloyd Sherman, running for Hazel Park Library Board; and David Nagy, running for Garden City Council.

Newsletter Director Andrew Wrenbeck discussed plans for the next Michigan Libertarian newsletter. Articles are needed. There was a discussion of newsletter content and focus. The deadline for submissions for the next issue is August 21, 2005.

Secretary James Hudler moved that David Raaflaub be appointed to the

vacant position of Membership Director. The motion failed for lack of a second. Political Director Leonard Schwartz moved that Kai Phillips be appointed to the vacant position of Communications Director. The motion was adopted unanimously and Phillips took office*.

Vice Chair Boman moved that the LEC authorize the Chair to take action to make lpmich.org a property of the LP of Michigan. The motion was adopted.

There was a discussion of preliminary reports that the national Libertarian Party's Libertarian National Committee (LNC) had earlier that same day voted to eliminate a dues requirement for national LP membership. At this and other points during the LEC meeting there was discussion of the LNC's action; of associated long-term problems with the updating of the LPM's membership database; and of collection of LPM dues. No action was taken. Membership in the Libertarian Party of Michigan continues to require a payment of dues.

Vice Chair Boman moved that any prior or current member of the Libertarian Party of Michigan be recognized as a member unless they have withdrawn their membership; and that anyone recently claiming to have paid dues and not credited as having done so be sent the next two issues of the Michigan Libertarian while the LEC investigates the matter. The motion was adopted.

Tim O'Brien presented information on the Michigan Civil Rights Initiative (MCRI), in which many Libertarians are participating. O'Brien urged that LPM members perform grassroots organizing for MCRI.

Political Director Leonard Schwartz proposed that the LEC authorize up to \$2000.00 to do a mailing to current and past LPM members about MCRI; that MCRI help create and design the mailing; and that the mailing be a dual mailing for MCRI and for [building] LPM membership. The motion was adopted, with Phillips objecting.

Treasurer Will Tyler White arrived at approximately this time.

The Treasurer's Report was presented and approved.

Jim Allison, Chair of the Macomb County LP affiliate, reported on his affiliate's plans for LibertyFest, which is scheduled for November 19, 2005.

Secretary James Hudler, a member of the Washtenaw County LP affiliate, reported on his affiliate's plans for the LPM 2006 Nominating Convention, to be held Saturday, May 13, 2006 at the Comfort Inn and Conference Center, Chelsea, Michigan.

A Libertarian Kit Kat Klub Cabaret is planned for Friday night.

Morning and afternoon business sessions on Saturday will be punctuated by a lunch with featured speaker and an evening banquet. Left-over business and completion of candidate forms may be accomplished Sunday morning if necessary. Hudler also called for volunteer staffers at the LPM information booth at the Ypsilanti Heritage Festival, August 19-21, 2005 (call Larry Johnson, 734-320-7237).

Treasurer Will Tyler White discussed the We the People Coalition, an organization of minor parties for the mutual endorsement of candidates. There was a consensus that LPM Bylaws forbid endorsement of the candidates of other parties.

Vice Chair Scotty Boman discussed plans for an LPM Leadership Conference. It was informally agreed to hold the Conference on October 2, 2005, the date of the next LEC meeting. The Chair indicated his willingness to change the LEC meeting agenda to permit the holding of the Conference on the same day. A second Leadership Conference was tentatively set for March 26, 2006. Meeting adjourned at 5:00 pm.

3. People who are fed up with the Democrats and Republicans are more likely to vote for Libertarians than for other small party candidates. The Green Party is an ultra-liberal party, which appeals to voters who consider the Democrats too conservative. And the US Taxpayers Party is an ultra-conservative party, which

appeals to voters who consider the Republicans too liberal. But the Libertarian Party is the middle of the road party. We can attract the great mass of voters, who aren't ultra-liberal or ultra-conservative.

4. Next year the Michigan Civil Rights Initiative will be on the ballot. It seeks to prohibit racial preferences in admissions at state colleges. It doesn't seek to eliminate the racial goals or quotas for employers who receive more than \$10,000 from the federal government.

Most voters think that the Supreme Court or the Democrats are responsible for racial preferences by the government. They are unaware that racial preferences were started by President Nixon and were supported by every subsequent Republican president and governor. They are unaware that racial preferences are still supported by the leadership of the Republican Party of Michigan.

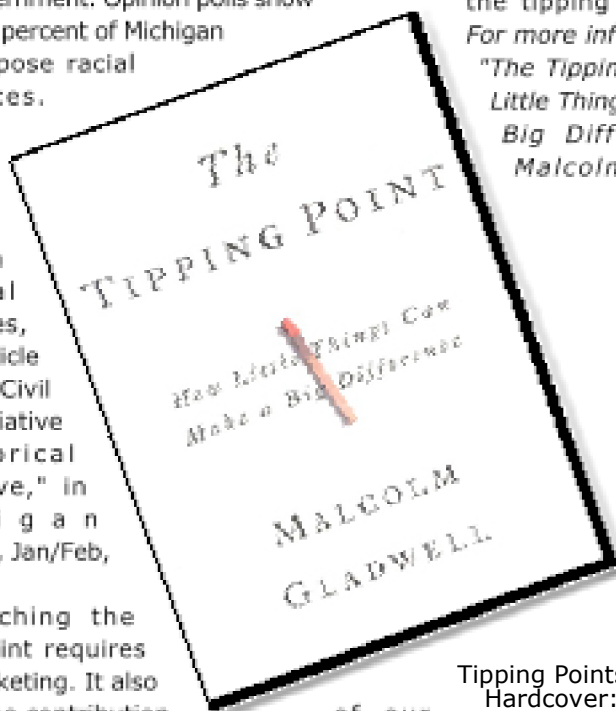
Although MRCI will have little practical effect on government policy, we

can use the racial preferences issue to increase public support for Libertarian candidates. MRCI gives Libertarians a great opportunity to inform voters that the Libertarian Party is the only political party that opposes racial preferences by the government. Opinion polls show that 60-65 percent of Michigan voters oppose racial preferences.

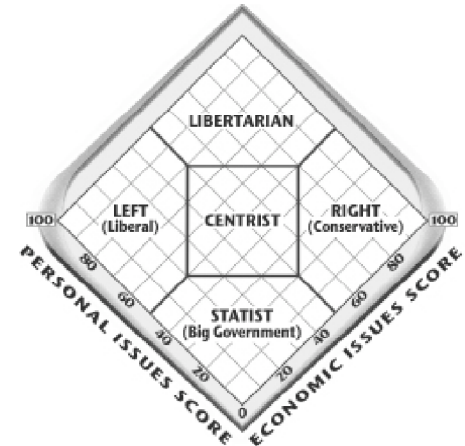
