NATCOM REPORT

The Libertarian Party National Committee met on December 14, and 15 in Washington, D.C. At the meeting, the NatCom was completely reorganized on a functional basis, effectively eliminating any subcommittees. The Four functional areas and their leaders are:

Administration - Mary Gingell, National Chair, Organizing (i.e. campaigns) - Steve Dasbach, Vice Chair, Development (i.e. fundraising) - Sharon Ayres, Education (i.e. LP News, Outreach, etc.) - Joe Dehn, Reorganization is designed to focus the efforts of the NatCom on those areas particularly within its mission.

The NatCom committed to ballot access in all 50 states, plus the District of Columbia, in 1992, at least on an interim basis. Two of the most difficult (and expensive) ballot access petitions will be in Pennsylvania and Oklahoma, and the decision as to proceed with those drives does not need to be made until the April NatCom meeting. Hence, the thought was that, depending upon ballot access receipts as of April, the decision whether to proceed with 51 in '92 could be made at that time. Nancy Lord appeared at the meeting and indicated that the Marrou/Lord Campaign will commit \$75,000 to ballot access following the New Hampshire primary. The NatCom budgeted an additional \$155,000 for ballot access, which would have to be spent in the first eight months of 1992.

The NatCom adopted a budget for 1992 which constitutes an increase of about one-third over 1991. While the budget, on an annual basis is deemed achievable, a significant cash flow problem could arise during the middle of the year because of the enormous cash demand posed by ballot access. Hence, it will be very important for contributors to give early and give often during 1992.

While a form of contract acceptable to both the Salt Lake City convention contractor and the NatCom was approved at the meeting, indications following the meeting were that the convention may not be held in Salt Lake City in 1993,

due to the convention contractor's inability to move the proposed convention into a different hotel and facilities which can better meet the needs of the National Convention. It is thus possible that bidding for the 1993 national convention may be reopened, or the convention rescheduled for Salt Lake City in 1994.

It was announced that the National Party should soon have available an organizing manual for use by state and local parties. In addition, the NatCom plans to have professionally produced brochures focusing on various Program planks, which will be provided to candidates in a camera ready form, so the candidate may incorporate his or her own pictures and campaign messages into the brochures.

Good progress was made in the November elections, with Libertarians winning approximately one-third of those elections contested. Joe Knight is busy organizing in the eastern part of the county, and is meeting with great success. In particular, he helped organize a meeting which reestablished an active party in West Virginia.

The NatCom's next meeting will be in Ann Arbor, Michigan, April 10-12, 1992, in conjunction with the Libertarian Party of Michigan annual convention.
