#### PLATFORM MEETING SET

The Libertarian Party of Michigan will choose a representative to the National LP Platform Committee and discuss a state platform at its Libertarian Advisory Council meeting on Sunday, February 11, in Lansing. The meeting will be held at Sneekers Restaurant, 600 Homer, at 1:00 PM. Sneekers is near the Michigan Ave. exit of US-127.

The position of National Platform Representative is normally chosen at our April Convention, but because the National Convention is in July this year rather than the usual September date, the person must be selected early because of all the preliminary work needed. Elections for delegates to the National Convention will be held at our April event and the permanent platform rep can be confirmed as a delegate at that time. The LPM is entitled to a position on the platform committee as one of the largest delegations.

The LPM will also discuss whether to have a state platform and if so, what planks are to be included. If it is decided to have one, the platform will be confirmed at the State Convention.

If there is not a quorum for the Libertarian Advisory Council, the Executive Committee will meet in its stead. All members of the LPM are welcome..

# CANDIDATE TRAINING SEMINAR A WINNER

The LPM Candidate Training Seminar was held on Sunday, November 19, at Jon Coon HQ in Ferndale before an enthusiastic audience. Barbara Goushaw conducted the session which was comprhensive, covering such subjects as should you run, assessing your skill, establishing your image, fund raising, media relations, interviews, resources, campaign strategy, tactics and research. Candidates were invited to appear in from of the camera in an interview format and then critiqued via playback, a method we used in the early 1980's and revived in 1992.

Goushaw covered the material thoroughly and fielded questions. A good part of the information resulted from her attendance at the candidate training seminar at U-Cal-Davis (covered in the September-October issue of Michigan Libertarian) as well as her experience as Campaign Manager of the Jon Coon campaign for US Senate in 1994. Her presentation was clear, well researched and, as usual, witty.

Afeature of the meeting was a presentation by Jon Coon, relating what he learned as a candidate and his plans for his 1996 State Rep. race. Emily Salvette filmed the event.

State LP Campaign James Hudler also spoke, covering some of the legal requirements for candidates.

The seminar was attended by some thirty hopefuls, and all agreed that it was enlightening and encouraging. We hope to do this every other year, at least.

# APPEALS COURT HITS FORFEITURE LAWS

On July 13, 1995, the Sixth Circuit Court of Appeals decided U.S. v. Guy Jerome Ursery, No. 94-1127. In this 2-1 opinion, the court held that since the Federal Government had already settled a forfeiture case against Ursery's home for \$13,250, the Double Jeopardy Clause prevented his later criminal conviction. In the words of the Court: "we find that the civil forfeiture judgement against Ursery followed by his criminal conviction constituted double jeopardy. Consequently, we reverse the judgement of the district court, and we remand the case to that court with instructions to reverse Ursery's conviction and vacate his sentence."

The Sixth Circuit consists of Michigan, Ohio, Kentucky and Tennessee, so its interpretation of the federal Double Jeopardy Clause is theoretically binding on all local federal and state courts in those four states.

This matter was reported to us by F.E.A.R., Forfeiture Endangers American Rights, and John T. Paff, Secretary.

# LIBERTARIANS RUN FOR OFFICE

The Michigan Libertarian Party was represented in three local elections on Nov. 7, 1995. The Libertarian Party of Washtenaw County fielded candidates in 4 of the city of Ann Arbor's 5 wards along with staging a write in campaign for "None of the above". Libertarians also ran in non-partisan races for Milan City Council and Walker City council.

Voter turnout was low in this off election year. The lack of media attention concerning this year's elections probably hurt the Libertarians because low voter turnout means that the party faithful are the ones voting. Candidates did an impressive job none the less. Renee Emry received a record (for Ann Arbor Libertarians) seven percent in a three way race. Glenn Barr nearly unseated an incumbent in his race for Walker City council.

The Libertarian Party of Washtenaw County celebrated their campaigns with an election night party at the Campus Inn in Ann Arbor.

# WINS IN GEORGIA!

Two members of the Libertarian Party of Georgia won election to their city councils on November 7th, both in hard-fought races.

Bruce Van Buren won election to the Avondale Estates City Commission, placing first in a field of five candidates vying for two open seats. This was a non-partisan race. However, much was made of Bruce's party affiliation by the other candidates, including an 11th hour "hit" piece describing all the LP positions people usually talk about when one of our candidates has them running scared. This essentially made it a partisan race for Bruce, but a non-partisan race for the other four candidates.

Avondale Estates is Georgia's oldest "planned community", it has a very close knit society, and has the second highest median income of any city in GA. The town is on the National Historic Register, with city buildings which resemble an English Tudor Village, and lots of old money. Bruce, having lived there for five years, is considered a newcomer, and his election has really upset the good old boy machine.

Van Buren's campaign was managed by LP Campaign Committee Chairman Ron Crickenberger (that's me). The campaign spent about \$2,200.00 to win 428 votes. Turnout was high at over 55%. We put five pieces of literature into every household including a last minute endorsement letter signed by 35 members of the community. We put this out when we found out about the hit pieces charging Bruce with wanting vending machines filled with drugs, and guns and prostitutes in the elementary school. (Wins in Georgia! cont.) found out about the hit pieces on Sunday A former Libertarian Party member won a afternoon, got signatures of prominent people for a couple of hours, put the piece together till 1:00AM, got it elected to a three-year term on the printed at Kinkos and distributed to every home in the city by 5:00PM Monday.

In short, we out-walked, out-talked, out-mailed, out-issued, out-spent and out-thunk the forces of of his hand-picked good old boys, said and civil liberties. simply, "Well I'll be damned!"

Dewayne Metheny placed second in a field of six candidates vying for two spots to win a seat on the Auburn City commission. Metheny had come close to winning a seat on the council in a special election earlier this year. Methenys campaign was managed by veteran LP campaigner Larry Bolin. There were smear pieces in this campaign also, but not directed at Dewayne. This was also a non-partisan race, but two of the candidates made sure that their Republican affiliation was known.

# Focus on.... The Libertarian Party of Washtenaw Co.

The oldest and largest Libertarian organization in the state of Michigan is the Libertarian Party of Washtenaw County (LPWC). Centered in the college town of Ann Arbor, the LPWC is made up of of an interesting mix of old and new libertarians.

The Washtenaw Co. party devotes most of its time and resources to the city politics of Ann Arbor and the education "politics" of the University of Michigan. The LPWC has run candidates for city office for over 10 years. This year the group ran candidates in 4 of 5 city wards and in the one ward without a candidate the LPWC ran a spirited write-in campaign for "none of the above"

The LPWC also helps sponsor the Ann Arbor Libertarian League, a student group at the U of M that was founded by Libertarian Party pioneer James Hudler. The Ann Arbor Libertarian League was in fact the forerunner of the Libertarian Party of Michigan.

This years "None of the Above " campaign was described in the Ann Arbor News as the LPWC's "latest attempt at political guerrilla theater." Past "guerilla theater" has included a "bowl off" whereby prospective Libertarian candidates for city council went bowling to determine which candidate would run for mayor. Another episode featured the use of a fully functioning portable toilet that was brought to a city council meeting and had dollar bills "flushed" down it to illustrate the wasting of taxpayers dollars.

A local alternative newspaper "The Agenda", a left leaning weekly, featured this years slate of candidates in an election issue headline article entitled "Libertarian Uprising". The front page pictured a Statue of Liberty with marijuana leafs in her crown and a gun in her hand.

The LPWC is fortunate to have two large fairs in the county every summer: the Ann Arbor Art Fair and the Ypsilanti Heritage Festival. These two fairs attract thousands of people, many of whom will stop by the Libertarian booth. The booth has been an invaluable source of new contacts throughout the years.

The strength of any group is the people that make it run. The LPWC has been fortunate enough to have some of Michigan's best Libertarians involved with it. The Chair is held by libertarian legend James Hudler, the Vice Chair is Geoffery Foster, the Secretary is Richard Clark, and the Treasurer is Brett Cashman. State Party Chair Emily Salvette is active in the group as is Ann Arbor attorney David Raaflaub.

There are many other active members helping to do their part to further the cause of liberty. The LPWC meets every Thursday at 7:30 PM, at Dominick's on Monroe St. in Ann Arbor. Usually 10-20 people show up for the interesting talks and speeches that are scheduled. # Macomb County Prosecutor Visits Libertarians

Macomb County Prosecutor Carl Marlinga spoke to the November 8, 1995 meeting of the Libertarian Party of Macomb County. The topic of Mr. Marlinga's talk was his recent letter to the Macomb County Concealed Weapons Licensing Board in support of more lenient issuing of CCW permits.

I am of the opinion that the presumption of innocence should not apply to politicians. It is with that attitude that I attended the November meeting of the Macomb County Libertarian Party. I was aware that Mr. Marlinga had taken a stance in favor of granting citizens concealed weapons licenses and I wanted to learn specific details of his opinion as well as learn more about him personally.

I found Mr. Marlinga to be a thoughtful, engaging speaker. He covered his personal background as well as a brief Constitutional history regarding the right to keep and bear arms. He concluded that there is not much hope that the Supreme Court will protect individuals against actions of the states when it comes to gun rights. But the Michigan Constitution does the job just as well.

Mr. Marlinga supported the Cropsy bill. In the absence of its passage, he will use the criteria set forth in that bill when evaluating license applicants in Macomb county.

The most surprising part of the evening was when Carl indicated that at some future time, he might consider running for public office as a libertarian!

I questioned him about a slightly different aspect of Michigan law. Namely, that part of the weapons licensing statute that the sheriff or chief of police shall issue applicants a CCW permit unless he or she has reason to believe that the person will be a danger to him/herself or others. Carl's answer that I was correct boosted my spirits. Some months ago, I filed suit against Washtenaw County Sheriff, Ron Schebil concerning that very issue. A decision is expected in January.

Kudos to the Macomb County group and Jim McAbee for arranging Mr. Marlinga's appearance and for the fine job that they are doing.

# Former LPM Chair starts new group in Ionia

Former LPM State Chair (1987-89), Dick Whitelock, is starting a new Libertarian Party group for Ionia, Barry, and Montcalm counties. An information and organizational meeting was scheduled for Tuesday, November 21 at the Corner Landing Restaurant in Ionia. Whitelock invited the current LPM chair, Emily Salvette, to speak at the meeting. According to a flyer sent to residents in the three counties, the meeting invited people to, "discover how the Libertarian philosophy of individual rights, economic freedom, and personal responsibility can give you an alternative to the status quo of politics as usual."

Whitelock's group will increase the number of active affiliates in the state to thirteen.


So, on this holiday, I would like to express my thanks to some people who have influenced or inspired me in my personal and intellectual development.

## ON WINNING

There was a considerable variation in the election results among Libertarian candidates November 7. The percentages ranged from 37% to 1.44%. There will be differences between two-way and three way races and between partisan and non-partisan contests, but there are other factors as well.

In Ann Arbor, Rene Emry led the Libertarian ticket with 6.95%. While she may have been in a ward that has more independent thinking voters, one factor stands out. Rene Emry had an issue! In a televised debate, Rene called for Ann Arbor to declare itself a "medical marijuana freedom zone." As an attention-getter, it worked. She did not pontificate on general principles, she applied the principles to a hot-button issue, one with which she established her credibility as a multiple sclerosis patient. The disease may be a handicap, but she turned it into an asset, not as a sympathy plea, but as an authority on the subject. These are two of the lessons stressed by Barbara Goushaw in the candidate training seminar November 19, assessing yourself and finding the hot-button issues.

The next time around, voters are going to remember Rene Emry, and if she can add one or two more hot issues, should do even better. Look for Jon Coon to do the same in his State Rep race. He made his name on the gun issue, but will move on in a smaller race to find the hot issues there while benefiting from his '94 name recognition. Principles must be expressed in concrete terms to do well at the polls.

The Milan election was another instructive event. Walter White missed being elected by only 36 votes out of 2,575 cast. Each voter could have voted for 4 of the 6 candidates, but not everyone does. Suppose the average voter cast his ballot for 3 candidates. That would mean that 320 of 858 voters voted for Walter. That's 37%, matching

Glenn Barr's percentage in the Walker City Council race. Where we have active candidates in non-partisan races we do quite well.

Suppose White had another \$500-\$1,000 for newspaper ads or seven or eight more volunteers to cover precinct walks. Would that have translated into another 37 votes? Or 50? Or 100?

Just alittle more help might have put Glenn or Walter over the top.

- 1. Libertarians are going to have to come out of their shells and help our more active candidates. Those who do not run will have to support those who do.
- 2. Those who run are going to have to ASK for help. ASK Ben Bachrach for the mailing list in your district. Then ASK those on the list for money or help walking precincts.

As Barb stressed in her seminar, there are three rules in fund raising. 1-ASK. 2-ASK. 3-ASK.

Define your assets and weaknesses. Find the hot issues. Plan your strategy and tactics. ASK for help.

We have a consistent set of principles. We derive the right positions. We are articulate. We can win if we do it right.
