THE CONVENTION AND YOU

The 1996 Convention of the Libertarian Party of Michigan on April 19-21 in Roseville will be an important event in several respects, and YOU can be a significant part of it.

CANDIDATES. The LPM will complete nomination for public office at the Convention. County caucuses will have nominated many of the candidates for State Representative, county and local offices, but some remain unfilled and the caucuses will stay open through the Convention. Cross-county nominations for Congress and statewide offices will be made at the Convention. If you have not been nominated and would like to run, come to the Georgian Inn, request that you be nominated and fill out the necessary forms. We had 50 candidates in 1994 and would like to challenge our record of 100 in 1982. Or, you could volunteer to be a campaign manager. There will be training sessions for candidates and campaign managers conducted by Barbara Goushaw and Jon Coon.

ELECTORS. We must nominate 18 Electors for President and Vice President. (Remember the Electoral College?)

DELEGATES. We will nominate 35 delegates to the National LP Convention in Washington, DC to be held July 3-7, at which we will choose our Presidential and Vice Presidential Candidates and debate our national platform. We are the fourth largest state LP party in the USA and can be very influential, but we need to fill all 35 spots. If you are going to the National Convention come to Roseville and seek one of them.

ELECTIONS. On Sunday, April 21, we will nominate and elect the leadership of the LPM for the next year. We will select the nine-person Executive Committee (Chair, Vice-Chair, Secretary, Treasurer and five At-large Directors) and three members of the Judicial Committee.

BY-LAWS and PLATFORM. On Saturday, we will discuss any proposed changes to our By-laws and decide whether to have a state platform and what form it would take. This could be a lively session as libertarians are always excited about issues and the by-law session is usually animated.

All members who attend the Convention in April are delegates if registered and have been in the LPM for 30 days or more.

As a member of the LPM, you have much more influence and effect than the members of those two older, decrepit parties. There are several projects that need attention as well as the election year so you will have many opportunities to participate in the fastest growing political party in the country. Membership has grown in the LP to 14,256 nationally and to 528 in the LPM. Michigan members of the national LP amount to 686, and we are trying to recruit those who have joined National into the LPM.

Freedom is not costless. Eternal vigilance is not sufficient. Bitching about Clinton and Congress is futile. Ideas have consequences, but they must be put into action by planning, effort, money and the courage of our convictions. Independence from the British came at great cost and pain. It took 80 more years to end slavery. Are you ready to help finish the job?

"THE EVIL THAT MEN DO" (IS REWARDED BY GOVERNMENT)

The United States Marshals Service has given Arthur Roderick and Larry Cooper its highest award for valor as a result of their actions at Ruby Ridge, Idaho, in 1992. They, along with Bill Degan, began the firefight that led to the siege of Randy Weaver and family following their retreat to avoid charges arising from a failed attempt by the Bureau of Alcohol, Tobacco and Firearms to entrap and extort cooperation by Weaver and the subsequent frame-up and slandering of Weaver by the BATF.

Director Eduardo Gonzalez, in presenting the awards, cited Roderick and Cooper for their "exceptional courage, their sound judgement and high degree of professional competence."

What did these two sterling examples do to earn such high praise? They, with Degan, ambushed 14 year old Sammy Weaver and 25 year old Kevin Harris, neither of whom had committed a crime nor had any warning ("sound judgement.")

Roderick started by shooting the family dog ("professional competence.") Cooper then shot Sammy in the back, killing the boy as he ran for home ("exceptional courage.") Harris fired a quick shot in return, killing Marshal Degan who had already fired SEVEN shots, before running back to the cabin.

Senator Arlen Specter, who conducted the Senate Judiciary subcommittee hearing into Ruby Ridge, was surprised that the awards were made when the marshals were under censure by the subcommittee.

Perhaps Director Gonzalez will be given an award by his boss, Janet Reno, for the "Promotion of Organizational Imagery" ("coverup.") Why not? The BATF went on to Waco on the assumption that they had gotten away with it. So did the FBI which fired Gene Glenn, the on-scene commander at Ruby

Ridge who had tried to find a peaceful outcome (the punishment of the innocent) and later promoted Larry Potts who gave the go ahead for violent solutions in both Ruby Ridge and Waco.

In these two episodes, these federal agencies have engaged in entrapment, extortion, frame-up, murder, attempted murder, slander, use of a poison gas outlawed by the Geneva Convention, arson (OK, maybe it was 'assisted arson'), filing false reports, and perjury before two Congressional committees. The McCollum committee in the House whitewashed the Waco tragedy to boot.

Much credit must be given to the Senate Judiciary subcommittee for its objective, full investigation of the Ruby Ridge event. Senator Arlen Specter, Chairman, deserves great praise for his diligent, incisive cross-examination of a bunch of slimy liars and for his calling for the abolition of the BATF. Senator Patrick Leahy, normally no friend of libertarianism, also deserves credit for tough questioning as do Senators Herbert Kohl and Fred Thompson. Charles Grassely and Larry Craig also contributed, while Dianne Feinstein wavered and Spencer Abraham lobbed marshmallows at the Federales.

NEWS BRIEFS

The Detroit News carried an article by George Cantor on jury nullification on March 17, following the acquittal of Dr. Jack Kevorkian on assisted suicide charges. ("Taking the law into its hands; Do jury rebellions promote justice or threaten disorder?") The article was fairly well balanced, citing both good cases such as the 1735 Zenger trial which established freedom of the press in America, and bad cases such as the 1955 acquittal of the men charged with the lynching of Emmett Till. The experts cited in the article were most concerned about using jury nullification for racist reasons, but seemed to like it where victimless crimes were the issue. Wow! Are we making progress!

On the other hand, Commissar of Labor Robert "Third" Reich wants big business to do more retraining of workers who were not educated by the government schools in the first place. Of course, he opposes any privatization of the schools, via tax credits for parents, while proposing them for business. Huh?

The History Channel recently ran a bio of George Washington, extolling his honesty, objective judgement and his surrounding himself with wise counsel. A week or so later they ran a bio on Lyndon Johnson and HIS characteristics: dishonesty, bullying, deceit, unfaithfulness and cronyism. George was victorious in the Revolution, set high standards in fiscal responsibility and non-intervention in foreign affairs and term limits. Lyndon lost the Viet Nam War and the "War on Poverty", debased the coinage and rigged elections. Who says morality is relative?

Keith Edwards appeared recently on two radio talk shows, on WCHB and WXYT. The latter was the David Newman Show on the recent seat belt legislation. That Q and A was supposed to go 15-20 minutes, but went closer to 40! Our views are being sought more and more. No surprise with Slick Willie and Bob Dull around.

This is apparently the second batch of such cases. This is another situation in which bad incentives lead to bad results, this time tragic.

KAUFMAN ANNOUNCES FOR SUPREME COURT

Nationally prominent individual rights attorney Jerry J. Kaufman has announced his candidacy for the Michigan Supreme Court nomination of the Libertarian Party of Michigan. Kaufman, a legal educator and author, has attacked restrictive ballot access laws in Michigan to enable third party ballot access. A former candidate for Supreme Court as an independent, he states Court reform is a high priority. "Our Michigan Supreme Court is ranked almost dead last in terms of its output and productivity and it sets the tone for the entire state court system which needs major overhaul," Kaufman said. Kaufman has a background in tax, labor, health, securities and consumer law, and the rights of taxpayers and employees.

Kaufman is the producer of the Tommy McIntyre radio show on WPON 1460 AM and has appeared on his behalf before gun rights organizations.

"I am running a grass roots campaign to bring common sense to the Supreme Court," Kaufman said.

Kaufman was formerly associated with the Tisch Independent Party.

PLATFORM DELEGATES SELECTED

The Libertarian Party of Michigan will be well represented on the Platform Committee at the National Convention in July.

As one of the largest delegations, the LPM is entitled to two representatives on the committee rather than one. Tim O'Brien was named to one position by the National Committee. The other, selected at the Feb. 11 meeting by the Executive Committee, was Ray Warner. Max Dollarhite is the alternate. Early selection was necessitated by the early date for the National Convention. Delegates to the Convention will be elected at the State Convention in April in the usual manner.

LPM SUES STATE OF MICHIGAN

On March 5, 1996, the Libertarian Party of Michigan filed a lawsuit challenging the constitutionality of a new law that prohibits Libertarian Party members from serving as election inspectors. The suit was filed in Washtenaw County Circuit Court by attorney David Raaflaub requests the Secretary of State and Governor to show cause why Public Act 261 of 1995 does not violate the Michigan constitution's purity of elections and civil rights clauses. The action was approved by the Libertarian Executive Committee in a phone/e-mail ballot held between February 20-26, 1996, with one dissenting vote.

PA 261, signed into law on January 4 by John Engler, limits the appointment of election inspectors to Democrats and Republicans as members of MAJOR parties. Those claiming to be members of one of those two parties, but who are known advocates of another are excluded. A known advocate is defined to mean a delegate or officer of another party (all LPM members are delegates to our convention), or even someone who has made documented public statements supporting another party or its candidates. This could mean anyone who has written a letter to the editor, or backed Jon Coon. Thus the choice is to not support the party of your choice or be excluded from what is really a public office. It penalizes freedom of speech and in effect establishes two "official" political parties.

The law may have been intended to stop any one party from dominating the election process by requiring an equal split between parties, but at the very least discriminates against independents and third parties unintentionally. At worst, it is another example of the gross attempt to squelch opposition to the oligopoly. Since most politicians are lawyers, ignorance is no excuse. They should know better. It's a shame that we have to divert time and money from campaigning to educating the governor and legislature about constitutionality, much less morality.

STATE

LPM Minutes, 17 March 1996

The meeting was called to order shortly after 1:00 in Ann Arbor. Present were Salvette, Owen, Marsh, Nagy, Bachrach, Beavers, Coon, Edwards, and Hudler. Also present were Brinkman, Clark, DeVarti, Thompson, and S.Van Oast. The minutes of the January meeting were accepted without dissent.

The Treasurer's report was accepted and submitted for audit without dissent. Nagy pointed out that primarily due to ever-increasing membership, we are well above projected income for the year, with two months until the close of the year.

Of particular interest from Salvette's Chair report is the Volunteer Network, tentatively to be headed by Bill Carver, which will match people interested in volunteering for the party with people who have projects that need attending to.

Owen and Bachrach mailed 314 pieces of literature to Constitution Party members, now that their organization has fallen apart.

Because there was no quorum at the February LAC meeting, Ionia County's affiliate cannot be formally recognized until the convention.

No official notification from the Ottawa County affiliate that they are assuming responsibility for Muskegon County has been received; so we cannot yet send them the dues from Muskegon members.

Salvette suggested that the Platform Committee hold an open meeting at the state convention, on Saturday morning, to give members the opportunity to review the platform before the floor debate. Van Oast will arrange space for that meeting. Bachrach suggested that the committee include in the platform a mechanism for retiring it.

Owen was appointed chair of the Presidential Campaign Committee.

Van Oast reported no problems with convention planning. The Convention Committee is beginning the publicity and promotion for the event.

The Bylaws Committee reported that they will suggest two changes to the convention. 1) clarify our presidential nomination procedures for years (such as 1996) when the national convention follows the state convention. 2) the appeals procedure for affiliate recognition should be modified so that we "don't air our dirty laundry in front of the LPUS."

We will have at least 503 members as of April 15, so the Party has met and exceeded its membership goal for 1995-6. Ben Bachrach is resigning as Membership Director as of April 21, although he will continue to be the Database Manager.

Owen and Brinkman reported that the Mid-Michigan affiliate had got pledges of \$750 to open a campaign headquarters in East Lansing. Bachrach/Hudler moved to appropriate funds up to \$1000 to Mid-Michigan's Campaign Headquarters project. Coon/Hudler moved to amend the amendment so that the funds can be used for solicitation purposes only. The amendment passed 5-3. The motion, as amended, passed 7-1.

Nagy, who had brought up the prospect of incorporation of the Party at the 1995 convention, will bring it up again at this year's convention.

Owen/Coon moved to adopt the Standing Rules proposal as the recommendation of the LEC to the convention. Motion passed.

An idea was proposed to offer a banner emblazoned with "Libertarian Party of Michigan" to the affiliate who shows the greatest membership growth during the 1996-7 year. An Incentives Committee will determine the nature and conditions of such an award and report about it at the convention. Passed without dissent.

NEWS FROM THE WEST

SAM ADAMS DINNER

The Libertarian Party of West Michigan will be holding its 1996 Convention on Tuesday, April 9th, from 7:00-9:00 p.m. at the Papa Romano's restaurant (3580 Plainfield NE, east from Plainfield exit off of I-96) in Grand Rapids, Michigan.

At the LPWM '96 Convention, an ambitious new membership growth project will be announced. Currently, the LPWM has a little over 20 members. The goal for the new 1-year term will be to bring in 80 new members, bringing the total LPWM membership to over 100 members! This membership recruitment drive is being spearheaded by the newly appointed LPWM Membership Committee Chair Phil Walsh.

Also from the LPWM: Glenn Barr, after having served three 1-year terms as LPWM Chair, officially resigned at the end of the February 6th business meeting. He emphasized that he fully intended to remain active in the LPWM, but thought it was time to "mix things up."

LPWM volunteers will be manning the fundraising phones for PBS on Saturday, March 23rd. Members hope to receive some positive exposure for the Libertarian Party.
