## JIM LEWIS DIES AT 63

Jim Lewis, the Libertarian Party's 1984
Vice-Presidential candidate died of an
apparent heart attack at his home in Norwich, Connecticut on February 22. He is
survived by three sons, a daughter and his
mother. Lewis had been a Libertarian Party
member since 1980. He was a featured speaker at the LPM Convention in 1991 in Lansing
where he demonstrated the Operation Politically Homeless booth. He served 10 months
in federal prison in 1988 for refusing to
file income tax returns. "Jim was a really
fine person and a courageous Libertarian,"
said former LPM Chair Keith Edwards who introduced Lewis at that Convention.

## FROM THE CHAIR

Thank you for giving me the opportunity to serve as State Chair of the Libertarian Party of Michigan. I have thoroughly enjoyed meeting and working with you in our common efforts for liberty. In both membership and influence, the Libertarian Party has grown tremendously over the past two years. That growth has come from your hard work and commitment, and I congratulate you on the success you have made possible.

When I leave office on May 4, there will be many tools the new leadership can use as they continue to build the Party. The infrastructure of our organization is solid thanks to the volunteers who have made these functions work smoothly: Ben Bachrach database manager: Keith Edwards, newsletter editor; and David Nagy, Treasurer. Two finctions, affiliate group support and membership, are working well and will be expanding to serve local leaders and members. At the post-election strategy session and the State Leadership Conference in February Stacy Van Oast, Jim McAbee and Mark Heil received a lot of feedback from you which helped them develop plans to further strengthen these areas. These are plans that have already been set in motion.

With operations going smoothly, we can bolster the Party's most important area, the campaign function. The Libertarian Campaign Committee, serving upper-level educational campaigns, and the Libertarian Campaign Managers Association of Michigan, serving active campaigns, will be the vanguard committees for the next two years. I am delighted that Doug MacDonald, Barb Goushaw, Richard Clark and Fred Collins have directed their considerable talents towards helping all Libertarian candidates in Michigan through these two committees. Their efforts will help elect more Libertarians in November, 1998, which will continue the cycle of growing membership and influence.

While we have made progress over the past two years, there are two areas I hope can

be developed in the near future: Fundraising and media outreach.

We do not do much fundraising at the stat level because we want donors to support local groups and candidates with their co tributions. But as membership grows and a our growth depends on presenting a more professional image, the time will come wh we must start buying some infrastructure services -- when we reach the limit of our volunteer efforts. A planned fundraising program could include special events, direct mail and an expansion of our pledg program. The money generated could be use to do such things as hire a mail house to send out big mailings, have our outreach publications such as newsletters, convention brochures and information packets la out by professional graphic artists, and hire other professionals such as bookkeep ers. A good fundraising program could be and running in one or two years. What we need to do now is to find the right volum teer to coordinate the fundraising functi

With the help of Darryl Schmitz, a new vo unteer with public relations experience, are starting to put a media outreach program together. Darryl, with assistance fr the national LP staff in Washington, DC, developing a professional media packet th introduces our ideas and organization to the press. The next step is to develop a current, comprehensive media list with co tacts and fax numbers for all media outle in the state. Ideally, we should also fir a spokesperson (perhaps the next State Chair?) who LIKES to be in the spotlight and talk with the media. That person coul cultivate our public presence and raise t Party's profile statewide. The elements of a media program are well within our reach right now, but it will take a well-directed effort to get this function up to ful speed. But once it's running well, it wil produce the public attention the ideas of liberty deserve.

YOUR help has made the Libertarian Party Michigan successful and will take that success into the next millennium. As the

## MERIAN'S FRIENDS MISS THE POINT

As a long-time supporter of Dr. Jack Kevorkian, I am dismayed by the ballot proposal of "Merian's Friends" to put physician aidin-dying on the November ballot. These are well-meaning people who want very much to give people the opportunity to seek medical help in ending the pain, misery and hopelessness of terminal or agonizing disease. As one who watched his father die in total agony, aware of nothing but excruciating pain, I can agree with Merian's Friends on their goal, but not their method.

We already have the right to assisted suicide. A right is a moral principle sanctioning action in a social context. We have the right to peacefully preserve our lives as human beings which includes the right to control our own life, to end it and to seek help in doing so. We had this right long before governments existed.

To seek governmental approval for this process to is give away our freedom to exercise our rights. Note the difference. We always have the right, government cannot take that away. We do not always have the freedom and that is what governments are so good at: taking freedom away. Why invite them to do so in this case? If the voters sayno, that would invite prohibition. If they say yes, we've still conceded the power for government to say no.

If government had been empowered to decide the case, would it have allowed Dr. Jack Kevorkian to help Merian Frederick to seek release from Lou Gehrig's Disease? Not likely. But she needed no such permission and we do not need a law on the subject.

## BUMPER AS DUKE

Jacob "Bumper" Hornberger, in his Ann Arbor speech (see page 8) was his usual uncompromising, inspiring self that makes him arguably the best speaker in the libertarian movement. During that address, he hit hard at Libertarians who soft-pedal the principles of libertarianism for a few quick votes at the expense of long term freedom.

Newt Gingrich, who is just two indictments away from the White House, has already destroyed the Republican revolution with, among other cowardly displays, his caveins on the minimum wage and tax cuts despite his professorial pretensions. We expect departures from stated principles among Republicans. Alas, sometimes it occurs among Libertarians.

In the last election, a number of Libertarian candidates, either through inadequate understanding or a desire to appear more "responsible", caved in on the education issue by advocating vouchers rather than privatization. They blanked out the fact that a government voucher is a government promise which means government control, not liberty. Who is to define what qualifies a school, or a teacher? Why not the free market?

Hornberger condemned vouchers as being a compromise. One does not uphold principle by backing away from the truth or from one's opponents. If you say you're for liberty, then always back the libertarian position. As John Wayne used to say, "I've given my WORD!" Maybe Jacob Hornberger, a Texan, should be called "Duke."

The National Leadership Conference, SUCCESS 97 was held March 1-2 in Washington, DC. The attendees were LP officers and head-quarters staff, LNC members and State Chairs (from the eastern half of the U.S.) A similar conference for the western half was held the next weekend.

The headquarters staff included the newest member, Ron Crickenberger. His new position of Political Director was filled 48 hours prior to the conference. Ron has worked long and hard for all of us as Chair of the LP Campaigns Committee and was re-elected as at-large member of the Libertarian National Committee at the July convention. As he assumes his new position he steps down from the LNC. He will shift from 20-30 hours per week of voluntary work for the Party to 50-60 hours for pay. Ron will be a great addition to our talented staff.

Nine topics were covered over the two days. Each segment included a presentation and ample time for discussion and sharing by the participants. The blend of great instruction with years of experience resulted in highly effective sessions.

Topics included: The Road to Victory, LPHQ Services, Convention and Meeting planning, Building a Strong State Party, Building a

Strong Local Party, What's New from LPHQ, Fundraising, and Looking Toward the Future

The wrap up was enthusiastic and many participants expressed the view that this had been their most important LP function. It is difficult to share in this brief report the depth of contribution and sharing that was developed. ## OUR WACKY GOVERNMENT

The Federal Highway administration spent \$21 million to pay for unused and unneeded roads and bridges.

-\$900,000 for a four lane bridge that had no road leading to it.

- 6.5 miles of new roadway, because traffic was supposed to double in 20 years. Traffic declined by 50%.

-\$26,000 for two extra long overpass bridges because it was expected that the road underneath would be widened to four lanes.

Twenty five years after the money was invested, the road underneath remained two lanes.

\$100 million is spent each year to pay for free subway rides for federal employees.

The Department of Defense spent \$28,000 to shuttle nine members of Congress to Washington in a posh executive jet so they wouldn't miss a close vote on the MX missile. The vote lost. So the DOD flew them back at a cost of \$16,016. The same trip on a commercial airline would have cost \$1,367.

The National Oceanic and Atmospheric Administration established the Office of Aircraft Operations (OAO) to improve aircraft management. OAO bought two helicopters for \$1.9 million to be used to improve safety in the Arctic by exploring the Arctic Continental Shelf. The choppers are stationed in Miami.

The Rural Electrification Administration (REA) was established to loan money to bring telephone and electric service into rural areas. By the 1950's however, 96% of the country had been wired, so the REA's job was done. Instead of closing down shop, REA began making loans to nuclear power plants that later went bankrupt.

Now the money is going:

- -to provide touchtone telephones to Micronesia
- -to run ski lifts in Vale and Aspen, Colorado
- -for electricity that powers golf carts in Hilton Head, S. C.
