Van Oast Elected Chair

Stacy Van Oast of Richmond was elected Chair of the Libertarian Party of Michigan at its annual Convention May 2 at the Southfield Ramada. She was elected by acclamation after Chair Tim O'Brien declined his nomination. Van Oast had served two years as Vice Chair following two terms as Chair of Macomb County.

Also elected by acclamation were Vice Chair Teresa Pollok of Brighton, Secretary Keith Edwards of St. Clair Shores and Treasurer Dave Nagy of Livonia (his 8th straight term.)

To round out the Executive Committee, five at-large Directors were chosen. Mark Heil and Doug MacDonald were re-elected and Bruce Hoepner, Dan LaFavers and Nancy O'Brien won for the first time over Bill Gelineau and Katherine Fisher.

Bill Hall, Jon Coon and Brett Cashman beat out Tom Jones for the Judicial Committee.

Van Oast promptly named Tim O'Brien to the revived position of Executive Director whose exact duties are to be determined, but will certainly include publicity. Further details on the business part of the convention are included in the minutes in this issue.

The convention began with the traditional Friday night party with lots of food and drink, entertainment and a fund raiser for the Oakland County LP in which party notables were sent to jail by so-called friends who bribed jailer Fred Collins. The victims were then bailed out by more contributions, raising over \$2,000!

The Success '99 training program was held on Saturday and Sunday, winning praise from those attending. National Executive Director Steve Dasbach presided over presentations by Michael Cloud, Mary Ruwart and Barbara Goushaw.

Bill Ballenger, publisher of Inside Michigan Politics, was the keynote speaker at the Convention Banquet. Clearly libertarian –leaning, Bill offered some interesting ideas and constructive criticism.

Oakland County LP sponsored the Convention under the direction Of Pam Collins. She and her staff did an excellent job. On her planning committee were Greg Dirasian, Tina James, Lloyd and Jeannie Sherman, Bob Black, Katherine Fisher, John Robertson, Lorna Tate, Ann Bora and Mark Heil. Heil and Ben Bachrach handled the registration and Fred Collins, Barb Goushaw, Doug MacDonald, Dave Nagy, Tim O'Brien and Stacy Van Oast also helped.

O'Brien Announces Radio Ads

At the Convention Banquet, Chair Tim O'Brien raised \$5,481 from those present for use in placing issue-oriented radio ads. He played three examples that were very favorably received as the total raised shows. All of the money will go to air time as Tim provided the ads at no cost. They began running a week after the Convention on WJR and WXYT in Detroit, WJIM in Lansing and WOOD and WTKG in Grand Rapids, all on talk shows. Stacy has sent a letter to those who did not attend the convention, asking them to match the amount which averaged \$75 per delegate. 1999 Convention Minutes

The 1999 Convention of the Libertarian Party of Michigan was called to order at 4:23 PM on May 1 by Chair Tim O'Brien.

Credentials Committee Chair Ben Bachrach reported that there were 63 registered delegates, quorum was 32. There were 34 present.

The standing rules were adopted without change.

By-laws Committee Chair Keith Edwards reported that the committee recommended no changes and that the Jones tabled motion from 1998 was not acted upon. Tom Jones then moved his proposal for a complete change of By-laws. Seconded by Brett Cashman. It failed. No other action was taken.

Platform Committee Chair opened debate on the Platform. Proposal 1 by Fred Collins To strike the second sentence of the assisted suicide plank. That was amended by striking the words "terminally or hopelessly ill". Amendment passed and the motion passed. Section XI, Paragraph 2 no reads: We support the right of persons to end their lives and we oppose legislation restricting so-called "assisted suicide."

Proposals 2 and 3, submitted by Dick Whitelock, moved by Jones relating to the oath of public officials and the State Officers Compensation Committee were defeated.

Proposal 4 by Jones to establish a unicameral state legislature by abolishing the Senate and abolishing the governor's veto power were defeated.

Proposal 5 by Jones to amend Section II adding Paragraph 5 was passed. It reads: We call for having the right of the voters to circulate any issue petition for at least 2 years.

Other Jones proposals to amend section II abolishing primaries, calling for non-partisan nomination of statewide officers, reducing legislative and executive terms to two years and judicial to 6 and recall failed.

The meeting recessed at 6:00 PM

The Convention was called back to order at 2:21 PM on May 2 by Chair Tom O'Brien.

Credentials report by Bachrach was 70 registered delegates, quorum 35. Present, 53.

Election of the Executive and Judicial Committees were held.

State Chair: Stacy Van Oast was nominated. No other nominations were made. It was moved that she be elected by acclamation. Passed.

Vice Chair: Teresa Pollok was nominated as was Ben Bachrach who declined. Pollok elected by acclamation.

Secretary: Mark Heil declined. Keith Edwards nominated. Lorna Tate declined. Edwards elected by acclamation.

Treasurer: Dave Nagy was elected by acclamation.

Motion by Greg Dirasian to amend Standing Rule 3 to require 5 seconds to a main motion failed. Motion to reopen debate on the Platform by Brett Cashman failed. Convention adjourned 3:45 PM.

Liberty Lines

The LPM **radio ads** described on page one produced at least 171 calls to National headquarters in the first two weeks of the campaign. That is the number of callers who specifically mentioned the ads when they called. There may be others who did not mention the ads, but called because of them. That's a good indication that the campaign is working. Let's hope we get more donations so we can expand the program.

On the other hand, LPM membership has leveled off and we have dropped from third place to fifth among state LPs. Texas and Florida moved up to third and fourth because of aggressive recruiting and Georgia is creeping up on us. Each of us needs to do some recruiting. You might make some copies of the membership form on page 11 for those times when you are talking to someone who seems receptive, a friend, family or a small business owner.

Thomas Jefferson, the first libertarian President, probably did not father any slaves, contrary to published reports. Only the youngest child of Sally Hemings, Eston, has been confirmed by descendents' DNA as a possible Jefferson offspring, but the DNA sample came from a descendent of Jefferson's uncle and any of eight Jeffersons could be implicated. This is from Herbert Barger who arranged for the Jefferson blood donors. Jefferson was about 65 when Eston was conceived, making him the least likely of the eight.

The Office of Foreign Assets, a Treasury agency that enforces anti-terrorist sanctions, unfroze the bank accounts of Salah Idris, who owned the pharmaceutical plant in Sudan that Mad Bomber Clinton attacked August 20. While not admitting that the bombing was a mistake, the federales' action seems to confirm that it was.

Those who wonder why we did not declare war before bombing Yugoslavia, should read Brian Mitchell's April 21 article, "What If Congress Declared War?" in Investors Business Daily. Mitchell points out the extraordinary war powers a President has: suspension of habeas corpus, summary deportation, economic controls, passport restrictions, censorship, rationing,

internment (100,000 Japanese Americans in World War II) and conscription. As one who lived through WWII, I'll take an undeclared war over dictatorship anytime.

On May 6, the day before the 100th anniversary of the birth of Friedrich Hayek, both the Wall Street Journal and Investors Business Daily carried both an article and an editorial on the Austrian economist. On April 6, IBD reviewed Human Action by Ludwig von Mises on the occasion of the book's re-release.



The Libertarian Party of Washtenaw County (LPWC) raises funds annually at an event that honors the Boston patriot Samuel Adams, who is often called the Father of the American Revolution. This year, The Sam Adams Liberty Festival was held on a sunny but cool Saturday afternoon, on April 17, 1999 at the Pittsfield Grange Hall in Ann Arbor.

While participants were eating, they had the opportunity to chat with Benjamin Franklin (alias James Williams of Monroe) who was dressed in attire appropriate to a colonial gentleman, he circulated through the crowd telling tales of colonial life, American Independence, and his own unique accomplishments.

After enjoying lunch the adults and some of the older children headed upstairs for the "Town Meeting."

After I gave a brief history about Samuel Adams and the Boston Town meeting, James Hudler, LPWC Chairman introduced the first speaker: Steven Russell from the N.R.A. Mr. Russell showed a video documenting the erosion of gun rights in America. The second speaker, Albert McCallum, an attorney and farmer from Springport, Michigan, talked about how zoning laws were destroying traditional property rights in our communities. Jason Eyster, the third speaker, who is an Ann Arbor immigration attorney, told of how current government policies close our boarders contrary to our historical tradition of open immigration. The final speaker was Stacy Van Oast, state Chair of the Libertarian Party of Michigan. She told us why she became a Libertarian, why it was in our self-interest to join the Libertarian Party, and encouraged everyone to vote Libertarian.

Garry Kaluzny and Friends provided a wonderful program of music. It began with traditional music from the Revolutionary War era then worked its way through America's history in music. The audience was clapping, singing, and dancing to them all.

Special thanks to Diana Peacor who with help from Jim Heddle, was in charge of decorations and set-up. Dan LaFavers, who set up the welcome/registration table and Kurt Verhoff, J.P. Denoyer, and Arthur Gulick who helped with clean-up.

It was the fifth time the Libertarian Party of Washtenaw County had organized a Samuel Adams fund-raising event. This year, the committee took a chance and tried something new with the family-oriented afternoon festival. Over 50 adults and 25 children took part in this experiment. If the response of the participants is any indicator, the day was rousing success. Many people commented on how wonderful it was to have a Libertarian family activity.

While this format was not as successful at generating contributions as past fundraising dinners, there is no doubt that the day brought the LPWC a lot of good will. It also showed that there is a market for family activities within the Libertarian community. Perhaps the biggest benefit of the 1999 Samuel Adams Liberty Festival is that 25 members of the next generation now have a positive image of our political party; in the future, that may prove to be priceless.
