LPers Observe Tax Protest Day

Approximately forty libertarians gathered at the State Capitol Building in Lansing, last Saturday, in order to observe the occasion of National Tax Protest Day.

The protesters (displaying a variety of colorful signs and placards bearing anti-tax slogans) picketed in front of the Capitol, and distributed literature to visitors and passersby. Using the front of the Capitol as a base of operations, the demonstrators periodically paraded through the nearby downtown business district, passing out anti-tax literature as they went.

The libertarians also marched to the Internal Revenue Service office, located across the street from the Capitol, on two occasions. On their first foray, they staged a sit-down demonstration inside the office, and later, they picketed in front of the building.

The day's activities were highlighted by speeches, delivered from the steps of the Capitol, by Brian Wright, of Birmingham, and Patrick A. Heller, of Pontiac.

County Petition Drive Heads Appointed

Sam Hancock, of Dearborn, and Al Harris, of Ann Arbor, have been appointed, by LP chairman Bill Krebaum, to head up the LP ballot drives in Wayne and Washtenaw Counties, respectively. They will be responsible for organizing the petition drive efforts in their counties.

The state-wide petition drive, scheduled to begin July 4th, must collect a minimum of about 18,000 signatures. Once this goal is attained, the LP may run candidates in all partisan elections (national, state, and local) throughout the state. Mr. Wright gave a general exposition of the philosophy of libertarianism, as related to the question of taxation, and called for the abolition of the Internal Revenue Service.

Mr. Heller discussed his extensive (and, as yet, unsuccessful) efforts to discontinue his payments to Social Security. Heller then climaxed the day's events, as he proceeded to burn his Social Security card.

That evening, many of the participants attended an open house in the Michigan State University Union. The affair was hosted by the MSU Libertarian Alternative.

In Grand Rapids, the Kent County LP, and the Committee for Tax Relief sponsored anti-tax activities, as well. These included literature distribution, and a hot-air balloon ascension at Calder Plaza. In addition, Dr. Edward Facey, economics professor at Hillsdale College, delivered a speech at the Pantlind Hotel.

Delegates Sought for National Convention

Delegates to the 1975 national convention of the LP will be selected at the June meeting of the State Central Committee.

This year's convention, to be held August 28 through September 1 at New York's Statler-Hilton Hotel, will nominate the LP's presidential and vice-presidential candidates for next year's election.

Rent Control Beaten In Ann Arbor Vote

Due, at least in part, to a well organized LP educational campaign, Ann Arbor voters overwhelmingly turned down a rent control proposal in the recent city-wide election.

The misnamed Human Rights Party had placed a charter amendment on the ballot for the April 7 election. Had it passed, the proposal would have established a five member Rent Control Commission having the absolute power to determine rental housing prices in the city.

The campaign against the proposal was fought on two fronts, with the apartment building owners concentrating t

The campaign against the proposal was fought on two fronts, with the apartment building owners concentrating their efforts in the predominantly non-student wards while the LP set out to influence the student vote.

The Ann Arbor Libertarian League and Washtenaw County LP chose, as their theme, the threat of City Hall becoming "Big Brother," with the power to determine where and with whom one would live.

In the 1974 referendum on rent control, the predominantly student wards voted only 10% against a similar proposal.

This time, however, after a vigorous educational effort led by a determined team of hard-working libertarians, over 34% of the student vote went counter to the proposal.

The LP has taken a giant step in establishing itself as a prominent political-educational fixture in Ann Arbor.

Facey Speaks To Rotarians

Dr. Edward Facey, Hillsdale College economics professor, spoke Monday, April 7, to the Litchfield Rotary Club. Dr. Facey discussed current economic problems and the role of government ir the creation of those problems.

He stressed the burden government places on businesses and the role it plays in preventing natural economic adjustments. As a solution, Dr. Facey called for a return to laissez-faire.

Discussion following the presentation indicated that the members were in agreement with the sentiments expressed by the speaker. They asked questions as to what could be done politically to solve these problems. Dr. Facey responded with a short discussion about the Libertarian Party and the Liberty Amendment Committee.

BUCKLEY FLOORS FERENCY, BULLARD Right Uppercut KO's Lefties In Ann Arbor Bout – April 4

Though libertarians have frequently taken William F. Buckley, Jr. to task for his philosophical inconsistencies, this dissatisfaction was not evident on the evening of April 4th. It was then that Buckley, after delivering some prepared remarks, engaged in some exciting philosophic bantering with arch-leftists Zoltan Ferency and State Representative Perry Bullard (D-Ann Arbor) at Hill Auditorium in Ann Arbor.

Libertarians were genuinely enthusiastic about Buckley's speech, which treated the theme of the sanctity of the individual, and the suppression thereof in collectivist societies.

The best was yet to come, however, when Buckley engaged in some rather lively, informal debate with his antagonists. One of Buckley's most effective techniques, that of reducing his opponents bromideic arguments to their underlying principles, was clearly in evidence. In response to Perry Bullard's tirade against the alleged material extravagance in our society, Buckley replied, "If someone has some sort of 'kinky' desire to drive a Cadillac, you would forbid him from driving one. We would all be required to substitute the dictates of Perry Bullard for our own best judgement."

Buckley's mastery of the situation was so obvious that even Ann Arbor's liberal media organs were forced to acknowledge his victory.

Buckley noted that, in just the last twenty years, every single tenet of socialism has been refuted. Considering this, Buckley held that, in a sense, prospects for the achievement of a libertarian society "have never been better."

Ned Hutchinson, National Director, Dies

Ned Hutchinson, who was just recently appointed LP National Director, died suddenly on March 30, 1975. He suffered a heart attack while playing tennis in Sacramento, California, at age 44.

Until his defection to the LP last January, Hutchinson had been a long-time Republican. He held the key post of appointments secretary in former California governor Ronald Reagan's administration.

As National Director, Mr. Hutchinson worked out of the LP National Headquarters in San Francisco. His responsibilities included coordinating the various state ballot drives, as well as general organizational work.

When he joined the LP, Hutchinson stated that he had "regretfully concluded that the Republican Party no longer adheres to those principles of limited government, individual liberty, and the free market. The only principle that now guides the Republicans (and the Democrats) is the principle of power and survival."


