## From the Chair


(Ed. note - Mr. Hudler is taking a much needed holiday in the Big Apple. Before he left, however, he organized a news conference on the steps of the State Police Headquarters in East Lansing on Tuesday, 27 September. In place of the FROM THE CHAIR, the ML is reprinting the text of the news release.)

> L.P.M. ATTACKS THE RED SQUAD

James Hudler and Dr. Bette Erwin, Chairman and Vice-Chairwoman of the Libertarian Party of Michigan, today decried the activities of the Michigan State Police Red Squad. "The Red Squad, with its extremely powerful investigatory powers, violates First Amendment privacy rights, freedom of speech and the right of the accused to confront his accusers," Chairman Hudler exclaimed at a news conference in front of the State Police Headquarters on Harrison Road in East Lansing. The Red Squad was organised in the 1960's to gather information for possible prosecution of political subversives. Since that time it has gathered large amounts of information about many political dissidents which it has used against them.

The Libertarian Party of Michigan held this news conference not only to protest the Red Squad but also to show support for Detroit Senator David Holmes' bills before the State Legislature which would reduce the power of the State Police. These Bills would return the duties of law enforcement in Michigan back to local police and would reduce the State Police to a highway patrol.

The Libertarian Party, now considered by the Secretary of State's election office to be the third largest party in Michigan, has, since its founding, been a staunch supporter of civil liberties. They advocate the abolition of all victimless crimes laws. Further, they are fully opposed to covert surveillance of an individual's actions by government on private property without the consent of the owner.





WITHER?

This past year many memberships have not been renewed, pleas for money or equipment have been ignored, and, of course, costs for putting this newsletter out have not become cheaper. The ML has received favorable comments from other LP organizations in the U.S. and Canada, but it's obvious that the vast majority of Michigan LPers may not even read the LIBERTARIAN. So be it.

### EXECOM REPORT -BARB ROWE

Libertarian Party of Michigan Executive Committee meeting, held Sept. 18, 1977 at 34623 Fountain Blvd., Westland. The members present were Jim Hudler, Anne Bilinski, Bette Erwin, Jim Greenshields, Ray Warner and Barbara Rowe.

Anne Bilinski moved that Steve Mariotti be authorized to raise money for the purchase of recruiting tabloids put out by the National Farty. The motion passed.

Jim Greenshields moved that Jim Hudler be authorized to put out a press release in the name of the Party opposing the tyrannical power of the State Police and supporting State Sen. Holmes in his opposition. The motion passed.

Jim Greenshields moved that a press conference be called decrying the State Police powers. The motion passed.

Bette Erwin moved to adjourn. The motion passed.



NEW OFFICE KEYS

The deadbolt lock on the LP Headquarters door has been changed. Those who have keys (the DEXTER key) can throw them away. New keys are being issued to officers and one or two other individuals who have long-term legitimate business in the State Office.



#### NEWSPEAK?

It seems to be the common fashion for the media, both liberal and conservative, to talk about "reverse discrimination" What they mean by the term is whites who are qualified for a particular position, etc., are passed over in favor of so-called "minority groups". However, if you take this term at its face value you must assume and accept that (1) the word discrimination implied unequal treatment by whites of non-whites (almost specifically blacks), (2) whites usually never discriminate against other whites, and when they do, one must use a different term, and (3) non-whites never discriminate


